#### COMMUNICATIONS

#### 4. <u>CITY COUNCIL LIAISON COMMUNICATIONS</u>

Councilmember Donovan provided a brief update on Cal Trans homes, and the Just Cause Ordinance. Vice Chair Samuels voiced his concerns about unhoused people who are utilizing a vacant home across from his residence. Commissioner Vogel asked questions about the bike lanes.

#### 5. COMMISSIONER COMMUNICATIONS

Commissioner Ocon reported on the graffiti at the Skate Park including possible termites at the gazebo, and possible replacement of rules signs.

Vice Chair Samuels reported on the misuse of facilities and the state of our parks, and disregard for rules. He added that fields should be locked up, have additional fencing to restrict access, and address dogs destroying fields. With respect to the Skate Park, park murals may deter graffiti.

Commissioner Bissner reported on people who conduct business at parks such as personal training classes. She added that our parks are well maintained. Vice Chair Samuels added that he would rather see people use our parks than undesirable activities taking place. Community Services Director Pautsch stated that staff are looking into different ways to address this. Chair Rocha added that additional staff may be needed for this and possibly code enforcement.

Chair Rocha reported that the fire on Huntington Drive was the property she was living in. This caused displacement of residents, but she also thanked the Fire Department for all their efforts.

#### 6. STAFF LIAISON COMMUNICATIONS

Community Services Director Pautsch reported on the Golf Course Master Plan Request for Proposal; Transit Assessment Meeting scheduled for November 14; State of the City scheduled for December 5; Groundbreaking Ceremony for Berkshire Park on December 13.

Program Specialist Bell provided an update on Camp Med. The campers also enjoyed a walking trip to the local pumpkin patch.

Management Analyst Tallon provided an update on the Transit Division; a new hire will be onboarding in December; CNG Station is out of commission for repairs.

Community Services Supervisor Wilcox provided an update on Recreation division offerings; Halloween Spooktacular was well attended with 3500 people; winter registration is open for recreation classes; Breakfast with Santa is scheduled for December 9; facility rentals included 6 at the War Memorial Building, 3 at the Senior Center, and 1 and Eddie Park; 64 park reservations in the month of October. Ms. Wilcox also provided an update on Senior division offerings including the workshop for What to Do About Mom and Dad; Dumpster Day with 100 sign-ups; Hispanic Heritage Month; Dia de Los Muertos; Paint and Sip; new lecture series by Cal State LA; and an excursion to Tanaka Farms.
