NOTICE IS HEREBY GIVEN that the City of South Pasadena Cultural Heritage Commission will hold a Public Hearing on <u>Thursday, June 17, 2021, at 6:30 p.m. remotely by video conference</u> to consider a request for a Certificate of Appropriateness, Project No. 2317-COA/AUP, for a two-story 1,184-square-foot addition and alterations to an existing single-story, 1,660 square-foot single-family residence and to allow a new detached garage in the rear to be 2-feet from the side property line, located at 1020 Milan Avenue (Assessor's Parcel Number: 5318-010-027). Applicant's representative is Conrado Lopez.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities and Section 15331, Class 31 Historical Resource Restoration/Rehabilitation. Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet and not located in an environmentally sensitive area. Class 31 exemption includes projects limited to maintenance, repair, stabilizations, rehabilitation, restoration, preservation, conservation or reconstruction of historical resources in a manner consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties with Guidelines for Preserving, Rehabilitating, Restoring, and Reconstructing Historic Buildings (1995),Weeks and Grimmer.
