**NOTICE IS HEREBY GIVEN** that the City of South Pasadena Cultural Heritage Commission will hold a Public Hearing on <u>Thursday</u>, <u>November 18, 2021</u>, <u>at 6:30 p.m.</u> to consider a request for a <u>Certificate of Appropriateness</u> (<u>Project No. 2423-COA</u>) for a proposed one-story, 790 square-foot addition to an existing one-story, 1,064 square-foot single-family residence located at 1123 Donaldo Court (APN: 5318-013-064). The project applicants are architects Armen Hogtanian and Greg Crawford.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities and Section 15331, Class 31 Historical Resource Restoration/Rehabilitation. A Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet and not located in an environmentally sensitive area. A Class 31 exemption includes projects limited to maintenance, repair, stabilizations, rehabilitation, restoration, preservation, conservation or reconstruction of historical resources in a manner consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties with Guidelines for Preserving, Rehabilitating, Restoring, and Reconstructing Historic Buildings (1995), Weeks and Grimmer.
