NOTICE IS HEREBY GIVEN that the City of South Pasadena Cultural Heritage Commission will hold a Public Hearing on Thursday, August 20, 2020, at 6:30 p.m. remotely by video conference to consider whether the property at 1502 Bank Street meets the criteria for historic designation prior to proceeding through the City's application process for Design Review consideration by the Design Review Board, Project No. 2328-NID/DRX. Associated Design Review Permits for the construction of two new single-family homes will be presented to the Design Review Board at a later date. Project site is approximately 8,200 square feet, Assessor's Parcel Number 5319-003-016. Applicant's Representative is Kobe Biak. The project consists of the following applications:

- **Notice of Demolition** of a 1,442 square-foot single-family home and 240 square-foot detached garage built in 1908.
- **Design Review** of two new single-family residences (2,555 sf & 1,542 sf) with a 5-car basement level garage, and two decks (533 sf & 426 sf).

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities and Section 15303, Class 3, New Construction or Conversion of Small Structures. Class 1 exemption includes demolition and removal of individual small structures such as a single-family residence. Class 3 includes one-single family residence, or a second dwelling in a residential zone. In urbanized areas, up to three single family residences may be constructed or converted under this exemption.

This meeting is being conducted in compliance with Governor Newsom's Executive Order N-29-20 issued on March 17, 2020 to protect the health and safety of the public and to minimize the spread of the COVID-19 virus.
