Dear Ms. Hankamer,

I am writing to you to confirm the interest and concern of the Roman Catholic Archdiocese in connection with the landscaping plan that has been submitted and is pending for the front yard of the Holy Family parish property located at 1534 Ramona Avenue. We have been in communication with the parish leadership over the last months as they have attempted, in good faith, to satisfy the continued efforts from the Cultural Heritage Commission (CHC) which seemingly is now dictating the front yard landscape design in a way which the parish, respectfully, feels is far beyond the proper scope of such review.

Frankly, this matter has escalated to my level because it seems to have followed a rather irregular process with neighbors and their retained design consultant who has been allowed to dictate to CHC and the City rather than to have a collaborative process recognizing the validity of the parish plans and an independent evaluation by the City of the plans.

However, as we have been advised and as I believe you will agree, Holy Family has, in good faith, adjusted the landscape plan to fully comply with the neighbors' requests at the previous CHC meetings.

I understand that in an apparent effort to further delay or confuse the matter, some have inquired about the backyard landscape plans, suggesting that a potential backyard project be accelerated and integrated into this application. The Archdiocese and Holy Family have no approved budget to develop the backyard or undertake any fence replacement at this time. When that project is undertaken, as required under the relevant protocols and City codes, the plans will be submitted for approval. In that regard, while that planning has not been done, a review of the relevant requirements by the parish indicates that the there are no building code, city laws/ordinances or CHC authority that would integrate the backyard and fence project into the current front yard landscape project or be a basis to delay the front yard project even further.

Given that the plan for the front yard, as a project, has been adapted to meet the requests of the interested neighbors and is not integrated with any future planning, there appears to be no reason for any further delay. The Archdiocese fully supports the parish request that the City and the CHC act on and approve the plan at this time for the front yard landscaping at the residence at 1534 Ramona Avenue.

The parish, quite simply, wants to complete the work based on the currently agreed plans. However, if that is not possible or you are not prepared to approve the plan, we will need to consider whether, sadly, formal legal action is necessary. I trust that will not be the outcome.

Finally, in making this request, I want to note that the leadership term for Cambria Tortorelli expires on June 30 and there will be a new parish leader effective July 1, 2021. Both the parish and the Archdiocese are anxious to complete this project before the change of leadership.

Thank you for your consideration and I look forward to a positive outcome at your meeting this week.
