**NOTICE IS HEREBY GIVEN** that the City of South Pasadena Cultural Heritage Commission will hold a Public Hearing on <u>Thursday, June 17, 2021, at 6:30 p.m. remotely by video conference</u> to consider a request for a Certificate of Appropriateness, Project No. 2388-COA, for a 28-square-foot addition (porch enclosure) to an existing single-story, 1,309 square-foot single-family residence and to convert an existing 227 square foot detached garage into an Accessory Dwelling Unit, located at 2002 Oak Street (Assessor's Parcel Number: 5321-004-002). Applicant's representative is Carol Allen.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities and Section 15331, Class 31 Historical Resource Restoration/Rehabilitation. Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet and not located in an environmentally sensitive area. Class 31 exemption includes projects limited to maintenance, repair, stabilizations, rehabilitation, restoration, preservation, conservation or reconstruction of historical resources in a manner consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties with Guidelines for Preserving, Rehabilitating, Restoring, and Reconstructing Historic Buildings (1995), Weeks and Grimmer.

This meeting is being conducted in compliance with Governor Newsom's Executive Order N-29-20 issued on March 17, 2020 to protect the health and safety of the public and to minimize the spread of the COVID-19 virus, while maintaining transparency and public access.
