I am writing to voice my approval of the landscape project at 1534 Ramona Ave. The landscape project has been thoughtfully designed and then redesigned as per the recommendations of the neighbors. Additionally, an architectural historian made several changes to the plan to make sure the plans are keeping with the historical integrity of the property. I know several craftsman homes in our city that have changed their front yards to more drought tolerant plants and included courtyards much as the design for 1534 Ramona Ave. There are 2 examples on the street I grew up on, Windsor Place that have similarly changed their front yards to a more water friendly design, one with a nice water feature as well. They both add to the beauty of the street and do not take away from the design of either craftsman home. The house on the corner of Oxley and Brent is another shining example of an amazing drought tolerant landscape on a craftsman home that contributes to the beauty of the area, not takes away from it. I remember when that home had only grass. It won a South Pasadena Beautiful award after the redesign of the front yard.

I would like to address the fact that Mary Edminston, the previous owner, sold the property to Holy Family of sound mind and body with the hope it would be used by the church. She had the intention of Holy Family using the property to add to the growing church. The church has kept the property and not changed the exterior other than wanting to change the landscape into a more ecofriendly design. The design is beautiful and will add beauty to the street.

I have seen yards and gardens change on Ramona Ave. This property must be treated fairly and equitably when deciding whether it's design is suitable for this property. Bringing up the former property owner in comments without knowing her wants for her property is not acceptable by the neighbors. Mary sold with the intention of the church using the property while upholding the integrity of it. The design the church has presented has been thoughtfully done, with neighbor input and historical input as well.
