NOTICE IS HEREBY GIVEN that the City of South Pasadena Design Review Board will hold a Public Hearing on <u>Thursday, May 5, 2022 at 6:30 p.m.</u> through an in-person/virtual hybrid meeting to consider a Design Review Permit (Project No. 2442-DRX) for 1016 Palm Avenue, Assessor's Parcel Number 5313-014-013. The project consists of the following:

Design Review Permit for a 280-square-foot first-floor addition (94 SF to the front and 186 SF to the rear); a 158-square-foot front porch; a new 777-square-foot second-story addition; a 295-square-foot covered patio to the rear of the property; new windows and doors throughout; replacement of stucco to lap siding to an existing 1,355-square-foot single-family dwelling on a 7,500-square-foot lot within the Residential Single Family (RS) zone.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities. Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet, in which the project site is in an area where all public facilities are available and is not located in an environmentally sensitive area.
