NOTICE IS HEREBY GIVEN that the City of South Pasadena Design Review Board will hold a Public Hearing on **Thursday, January 6, 2022, at 6:30 p.m. through an in person/virtual hybrid meeting** to consider a Minor Hillside Development Permit and Design Review Permit (**Project No. 2418-HDP-DRX**) for 1900 Alpha Street, Assessor's Parcel Number 5310-010-026. Applicant's Representative is Chris Salas. The project consists of the following applications:

- **Minor Hillside Development Permit** for the remodel of an existing single-family home that encloses 89 square feet to the existing first floor and creates a new 947 square-foot second-story addition. The property is a hillside lot with an average slope listed as 25.21%.
- **Design Review Permit** for the remodel of the existing single-family home that includes modifying existing cladding.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities. Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet in which the project site is in an area where all public facilities are available and is not located in an environmentally sensitive area.
