NOTICE IS HEREBY GIVEN that the City of South Pasadena Design Review Board will hold a Public Hearing on **Thursday, February 4, 2021 at 6:30 p.m. remotely by video conference** to consider a **Design Review (Project No. 2297-DRX)** for 5049 Collis Avenue, Assessor's Parcel Number 5312-018-025. Applicant's representative is Paul Ashley, Architect. The project consists of the following application:

- **Design Review** for construction of a 583 square-foot addition, a 140 square-foot covered front porch, and a 50 square-foot rear deck to a single-story family home.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under 15301, Class 1 Existing Facilities. Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet in which the project site is in an area where all public facilities are available and is not located in an environmentally sensitive area.

This meeting is being conducted in compliance with Governor Newsom's Executive Order N-29-20 issued on March 17, 2020 to protect the health and safety of the public and to minimize the spread of the COVID-19 virus.
