NOTICE IS HEREBY GIVEN that the City of South Pasadena Design Review Board will hold a Public Hearing on Thursday, February 4, 2021, at 6:30 p.m. remotely by video conference to consider a Design Review (Project No. 2357-DRX) for 804 Milan Avenue, Assessor's Parcel Number 5318-007-034. Applicant's Representative is Odom Stamps. The project consists of the following application:

• **Design Review** to add 457 square feet to the first floor and 339 square feet to the second floor to the existing 2,623 square-foot home. The front elevation incorporates a new 191 square-foot porch with an expanded entryway. Attached to the rear of the house is a proposed 296 square-foot loggia that connects to a study and existing guesthouse. A 326 square-foot barbeque pergola is proposed adjacent to the guest house. The applicant also proposes changing the architectural style to Contemporary Craftsman Cottage.

In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 Existing Facilities. Class 1 exemption includes additions to existing structures provided that the addition will not result in an increase of more than 10,000 square feet in which the project site is in an area where all public facilities are available and is not located in an environmentally sensitive area.

This meeting is being conducted in compliance with Governor Newsom's Executive Order N-29-20 issued on March 17, 2020 to protect the health and safety of the public and to minimize the spread of the COVID-19 virus.
