I am sorry I will not be able to attend the Public Hearing in person nor the Zoom meeting for the Request for a Design Review Permit for 411 Alta Vista Ave..

Questions:

Where will the 38sq. ft. mudroom be built? Front or back of the house?

Where will cars/trucks park during construction?

Will there be someone directing traffic?

Will the construction crew clean up (nails/screws/food) each day before leaving?

Concerns:

Due to the location of this project parking and traffic will be an issue. *Homes in this area direct all their work vehicles/cars to park on Mountain View Ave.. Last week, there were 3 separate construction jobs with all vehicles parked on a very tight Mountain View Ave.. Due to the entry onto Mountain View Avenue being blocked, some resident's deliveries were not made and some home owners had no option but to park illegally due to the lack of parking spaces.

Fear is with this project and an ADU being built next door to it, there will be months of chaos with large trucks and vehicles coming and going and more than likely no one directing traffic...
