#### 2. Minutes of the Special Library Board of Trustees Meeting of July 21, 2022

#### 3. Administrative Policy Review: Rescind Policy on Harassing and Stalking Behavior

This policy was enacted in 1995. It hasn't been reviewed since 2002. Staff recommend rescinding the policy because it is an outlier in the Library Administrative Policy Manual (LAPM), which does not contain any other policies that address a single criminal behavior, and because it

is covered more appropriately in the Library Code of Conduct and in the South Pasadena Municipal Code.

Trustees discussed how the public might perceive the removal of the policy from the LAPM, given the public comment made about Library and Library Park health and safety at the August 11, 2022 Special Meeting. Staff explained that the Code of Conduct and Municipal Code together are the framework that is used by staff to enforce rules and regulations, and that the Code of Conduct states "verbal or physical abuse or sexual harassment of Library users or staff is prohibited" and "no illegal behavior of any type." The Municipal Code indicates the suspension of Library privileges for various behaviors that include "engaging in any behavior that may pose a written, oral, or physical threat to other patrons, volunteers, or library staff" and "seriously harassed verbally or physically, or aggressively or annoyingly stared at or followed other patrons, volunteers, or library staff about the library premises." Trustees concurred that the issue of stalking and harassment are clearly addressed in these two locations and that including a policy on stalking and harassment in the LAPM is superfluous and potentially confusing.

Library Director Billings noted that Library staff are trained on how to deal with behaviors that are illegal or that are prohibited by the Code of Conduct and South Pasadena Municipal Code and involve law enforcement whenever circumstances require it.

Motion by Library Board President Vice President Bianca Richards, seconded by Library Board Trustee Secretary Annie Chang Long, to rescind the obsolete policy on harassment and stalking behavior in the Library Administrative Policy Manual.

#### 4. Library Educational Outreach Plan

The Library Special Tax will be on the November election ballot. Library staff will conduct educational outreach about services and programs. Staff will use social media to highlight different fun facts about the Library. A new and more compelling brochure will be produced. A Frequently Asked Questions flyer about the Special Tax will be developed to provide factual information about the Tax to the public.

#### 5. Programming Survey Results

Results were shared from the survey Library Board Secretary Long helped create for Library programs. The survey will resume in the fall for One City One Story and other adult programming, so as not to be confused with the Library Strategic Plan survey. Gathering program feedback was one of the goals from the 2016 Library Operations Study and the 2017-2022 Library Strategic Plan.

Nearly all responses were from parents at Storytime programs. 74% of respondents found the content valuable and would recommend to friends and family. Not as many people were likely to use other Libraries resources and services, but that may be due to demographics. No one indicated they heard of Library programs through emails or flyers. It should be noted that parents

do request printed calendars of events and the printed bookmarks for Press Reader clearly boosted usage stats for that resource, so staff believe that printed information is still in demand and utilized. Most became aware of programming from the Library website, a staff member, or from a friend or family member. Most comments had positive feedback. Respondents would like to see more hands-on activities such as arts and crafts or cultural activities in the future. Saturday Storytimes do typically have a craft element.

President Serwin was grateful for the responses and is eager to see what feedback the fall survey provides. An ongoing, open survey for general feedback about Library operations and services could be created.

#### 6. Library Strategic Plan Update

Over 300 responses have been received for the Library Strategic Plan survey. Survey invitations were sent to every community group. Friends Board representative Sally Kilby has been extremely helpful in getting the word out. A poster board and comment cards were made available at the Senior Center to capture the suggestions of those who may not be as likely to take the online survey. The survey has been sent out to parents and faculty in the school district. The survey closes on 8/18/22.

The Strategic Plan consultants will conduct additional one-on-one stakeholder interviews next week. The consultants will return on site between 9/6/22-9/8/22. They will hold a public meeting the evening of 9/6/22 where they will share the analysis of the data and seek further input from the community. The Board was encouraged to attend that meeting. There will be an all-staff session during the day on 9/7/22 and the Community Advisory Committee will meet that afternoon. Senior Library staff will review the findings with the consultants the morning of 9/8/22.

#### 7. Library Operations Update

The Summer Reading Program has wrapped up. 1,400 people, including 300 adults, signed up and read twice as much as last year. The 46 teen volunteers worked a total of 1,384 hours. 3,000 books were given away. 45 programs were held. Story Times had a total of 2,235 attendees.

The next session of Story Time will be 9/13/22-11/19/22.

The Teen Advisory Board received 22 applications for its fall cohort.

There will be a Ray Bradbury program in the Community Room on 8/20/22. Tim Carey will speak about the Ray Bradbury fused glass windows created for the Library Conference Room. Filmmaker John Sasser will show his documentary, *Father Electrico: Ray Bradbury Lives Forever!* about Ray Bradbury's collaboration with the sculptor Christopher Slatoff. There will be a Q&A after.

The One City One Story selection committee is working their way through the short list of books. Two finalists will be chosen for the public to vote for during the period of 9/1/22-9/10/22. The winning title will be announced later in September, to allow time for the Library to purchase and catalog copies.

Public events related to One City One Story have been scheduled. An Author Talk will be held on 10/4/22 with Jana Ireland for her book, *Regarding Paul R. Williams: A Photographer's View*. The Library will partner with the Community Garden to hold a hands-on natural indigo dying event on 10/16/22. The virtual book discussion will be 10/26/22.

The Library will partner with the South Pasadena Arts Council (SPARC) for a series of Author Talks. The first Author Talk is scheduled for 10/12/22 with the musician Leland Sklar.

The City Open House, which will include all City departments, will be on 10/2/22. It will take place on Mission Street in front of City Hall. The Library has fun activities, crafts, and some giveaways planned.

The first round of Digital Services Librarian interviews will be held 8/15/22. A second round of recruitment may be necessary. Three new Substitute Librarians have been on-boarded in the last week.

Meetings have been held with the City Attorney, Public Works, the Police Department, and the Community Development Department regarding the health and safety of the Library Park.

President Serwin asked to add a Discussion Item to the 9/8/22 Library Board agenda about the Library Board's policy for public comments.

Mayor Michael A. Cacciotti announced a Mobile Crisis Unit will begin next week to address the mental health crisis needs of the City. The Mobile Crisis Unit will include trained professionals to respond quickly to individuals experiencing mental health crises.

#### 11. Friends of the Library Representative

Friends Board Representative Sally Kilby reported the Friends provide funding for the Summer Reading Program and was glad to see it such a success.

The Friends newsletter comes out once a month.

Sally Kilby attended the Woman of Distinction event that honored Library Director Billings.

Sally Kilby was part of the Community Advisory Committee that met with the Library Strategic Plan consultants.

The Friends Bookstore celebrated its 40<sup>th</sup> anniversary in July. The memorial fund established in honor of the founders of the Friends Bookstore has raised \$1,300 so far.

The coupons offered for the Last Chance books was quite popular.

The Friends partnered with the South Pasadena Chinese-American Club and the Library to screen the documentary *Far East, Deep South* that played to a capacity crowd in the Community Room on 7/29/22.

The Friends Retreat will take place on 8/18/22.

#### **SPPL Vision Statement**

The South Pasadena Public Library is a welcoming gathering place in our community to build connections, support creativity and encourage learning.

#### **SPPL Values Statement**

We are passionate and dedicated to improving lives. We are open to all and honor the diverse nature of those we serve. We demonstrate character and integrity to our customers, fellow staff members and the community.

#### Background

As per its Vision Statement, the South Pasadena Public Library strives to be a welcoming gathering place. It is staff's opinion, based on experience, interaction with customers, results of surveys, and usage statistics, that the vast majority of the time it is a welcoming place that people use in comfort and security. The Library has rules and regulations that customers must follow. Staff are tasked with enforcing these rules. The South Pasadena Municipal Code gives the Library the authority to suspend any person's use of the Library for periods of up to one year, depending on the nature of the rule violation. As with any public facility, there are customers' use and enjoyment of the Library. The presence of persons suffering from mental illness, who are unable to manage their behavior, has increased over the past decade, and the pandemic seems to have exacerbated societal problems like homelessness and lack of access to medical care. Staff are employed everyday in serving the public and providing exceptional library operations.

The following information provides context for a discussion of Library and Library Park health and safety.

Library Code of Conduct/South Pasadena Municipal Code

The Library Board of trustees has the ability to enact bylaws, rules, and regulations "as may be necessary for the administration of the library" (SPMC 2.78(b)). Staff are responsible for enforcing rules. All policies adopted by the Trustees are contained in the

<u>Library Administrative Policy Manual</u>. Rules relating to customer behavior in the library are documented in the <u>Library Code of Conduct</u>. The South Pasadena Municipal Code provides a framework for suspending a person's library privileges when the rules are not followed. When a customer's privileges are suspended, they may not enter the Library or Library Park, except for the entry way to the Senior Center and the area within the Senior Center, for a set period of time. If they do come on the premises during their suspension, they are guilty of a misdemeanor.

#### Park Rules and Regulations and Enforcement

Following are portions of the South Pasadena Municipal Code that that relate to park use. Enforcement is the responsibility of the Police Department or City Code Enforcement Officer.

- No persons permitted in the park between the hours of 10 P.M. and 5 A.M. (SPMC 21.2)
- Campfires and barbeques must remain in existing pits and fixtures provided for such purpose. (SPMC 21.6)
- Dogs must be kept on a leash of not more than six feet in length. (SPMC 21.23)
- Dog leash must be held by person capable of controlling the dog. (SPMC 21.23)
- Dog excrement must be removed promptly. (SPMC 21.23)
- No littering. (SPMC 21.17)
- No alcohol and smoking. (SPMC 21.18 & 17.54)
- No graffiti and vandalism. (SPMC 20.41 & 21.21)
- No unauthorized livestock. (SPMC 21.3)
- No horses or other ridden animals. (SPMC 21.11)
- No unauthorized motorized vehicles. (SPMC 21.11)
- No mechanical toys and model airplanes. (SPMC 21.19)
- No unauthorized firearms and fireworks. (SPMC 21.5)
- No unauthorized sales or offer to sell any article, merchandise, or thing whatsoever. (SPMC 21.16)
- No unauthorized carnival devices, including inflatable structures, such as bouncers and jumpers. (SPMC 21.25).

#### Park Signage

There is currently only one sign, on the El Centro side of Library Park, that provides a comprehensive list of rules and regulations. Library staff is working with Public Works to get 6 new signs made, for placement on balconies, Oxley and El Centro entrances, and Senior Center side door. They will highlight the regulations that are most relevant to the common behavioral problems:

NO PERSONS PERMITTED IN THE PARK BETWEEN 10 P.M. AND 5 A.M. (SPMC 21.2) NO LITTERING (SMPC 21.17)

NO POSSESSION OR CONSUMPTION OF ALCOHOL (SPMC 21.18)

NO SMOKING (SPMC 17.54)

NO GRAFFITI (SPMC 20.41) NO VANDALISM (SPMC 21.21)

#### <u>Wi-Fi</u>

The Library's Wi-Fi signal transmits beyond the walls of the building. During the pandemic, many libraries invested in equipment and technology to boost their signals so they would be available in an even wider area beyond the footprint of the library building. South Pasadena did not do this. A password is not required to access the South Pasadena Public Library's public Wi-Fi network. Best practice in public libraries is to not require a password for access. Many years of experience have proven passwords are an inconvenience to customers and libraries have moved away from requiring them. A recent survey of Southern California library directors found that out of 16 libraries who responded only 2 were requiring passwords, and those passwords were readily available through signage, or were provided in the Wi-Fi network name.

SPPL Wi-Fi is available between 8:00 a.m. and 10:00 p.m. daily. 10:00 p.m. is when the Park closes. Library staff occasionally use Wi-Fi between 8:00-10:00 p.m. for evening events in the Community Room.

#### **Exterior Outlets**

To staff's knowledge, there is only one outlet that used to be used by the public and it has been permanently blocked off for some time. It is located on the Diamond Street balcony. There is one other outlet near the Oxley Street entrance but it is in the bushes so not visible or easily accessible. If necessary, it can also be blocked.

#### Los Angeles Homeless Services Authority (LAHSA) Requests

Staff regularly make LAHSA outreach requests for people that we observe to be in need of assistance. Our internal log shows that since July 2019 we have made 34 requests. We received confirmation from LAHSA that 14 of these requests were followed up on by a team member.

#### **Resources Brochure**

The Library has modified and updated a brochure that provides information about resources for people experiencing homelessness and other issues. This is given to people who we perceive may be in need or who make a request for assistance or information from staff.

#### Mobile Crisis Team

The City launched its' Mobile Crisis Pilot Program on Thursday, August 18th. A mental health clinician and paramedic from Los Angeles Centers for Alcohol and Drug Abuse (L.A. CADA) will be onsite for 10 hours each Thursday to assist law enforcement with crisis calls. Staff will provide regular updates to Council, and is scheduling for the L.A. CADA team to meet the local faith-based community, social services providers, and City

Staff. Library staff met with the team on Thursday, September 1, 2022. In the near future it is expected that a homeless outreach component will be added to this program.

#### Security Guard

A properly trained security guard could be a benefit to library operations. The Library does have a history of using security guards. In the early 2000s, the Library was experiencing large numbers of disruptive students in the afternoons. An outside agency was contracted to provide security guards. This was ultimately not successful due to the rapid turnover of guards assigned and the inability to train them to provide security appropriate to a public library setting, which is more nuanced and less heavy-handed than what the assigned guards were accustomed to in other settings. The Library then created a "monitor" position to manage the afterschool crowd. Since that time the dynamic has changed. While we do still have behavioral problems with youth, the greater concern is behavioral problems with adults.


#### Facility Maintenance

Interior: The Library has seven days per week nightly custodial service and daytime service three days per week. Any issues of cleanliness are typically reported to staff immediately and the necessary measures are taken to address the issues. For security reasons, the restrooms on the second floor near the Community Room are only made available to the public when there is an event taking place in the Community Room or when the restrooms on the first floor are out of service. The first-floor restrooms are open and accessible whenever the Library is open. With anywhere from 400 to 700 visitors a day, it would be impracticable to have the restrooms locked and access controlled with keys or a code system. The size of the existing public restrooms is completely inadequate to meet the demand. In spring of 2023, staff plan to seek funding from the California State Library for critical infrastructure improvements that would include a complete remodel of the public restrooms.

Exterior: The Public Works Department is responsible for the maintenance of City parks and the exterior of City facilities. The Library does contract with an outside vendor occasionally for special cleaning of balconies and entryways. Concerns about the accumulation of litter and the need for more frequent cleaning have been discussed with Public Works.


#### Security cameras



# Q2 2. Please tell us how much you agree or disagree with these statements:a. I enjoyed taking part in activities offered by the library this summer.



## Q3 b. I learned something because of activities offered by the library this summer.






## Q4 c. I got help from the library this summer.

## Q5 d. I plan to take part in library activities after the summer.








