Library Board President Serwin expressed appreciation for Library Director Billings and Library staff in adapting to the new format for conducting Commission meetings. He requested to resume the review of Library policies for the 11/9/23 Board meeting.

Vice President Richards reported that some of the neighbors have concerns that there will be an increase in public urination with the Library's early closure on Halloween at 6 p.m.

# 12. COUNCIL LIAISON COMMUNICATIONS

Council Liaison Braun said she would follow up with the City Manager regarding the installation of the new patio furniture. She will also speak with the Finance Department and the City Attorney about the financial and legal aspects of the City accepting and holding funds from private donors. She will host a dialogue session at her home on 11/5/23 from 11 a.m.-2 p.m. to review the past year and what still needs to be done. She noted that the City has made a lot of forward progress.

# 13. FRIENDS OF THE LIBRARY REPRESENTATIVE COMMUNICATIONS

Friends Board President Ellen Torres provided updates about the Friends' new website, the possibility of hosting local author events, and the formation of a nominating committee. The Friends budget will be presented in November and their holiday luncheon is scheduled for 12/7/23. Starting in 2024, the Friends and the Restoration Concert Committee will each sponsor a scholarship for graduating South Pasadena High School seniors. Details were provided about Friends membership, the amount of money raised by the Friends Bookstore, the sale of books on eBay, and their silent auction. The Friends Holiday Book Sale will take place from 12/1/23-12/3/23. The first Restoration Concert of the year was the most attended concert in the history of the committee, perhaps due to the publicity on Instagram. The Friends are developing a new, social-media friendly logo.

# 14. TRUSTEE LIAISON TO THE FRIENDS COMMUNICATIONS

Vice President Richards is very impressed with the newest and youngest members of the committee and their social-media expertise.

# 15. LIBRARY DIRECTOR COMMUNICATIONS

Library Director Billings announced that next week is "National Friends of the Library Week". The Governor signed SB 321, which requires public libraries to ensure the children in their local school district have library cards. Library staff have wanted to do this for some time, and are looking forward to forthcoming guidance from the California State Library. Any teen in the state of California can get a library card through Los Angeles County. An obituary for former Reference Librarian Michael Toman was published in the *South Pasadenan*. Director Billings and Administrative Secretary Sean Faye will attend a Parliamentary Procedure training. The Library will not receive California State Library Building Forward Critical Infrastructure grant funding. This will be discussed at the 11/9/23 Board meeting. Director Billings attended the *Library Journal Design Institute* in Hayward, CA, where she met with several architectural firms and visited the recently built Hayward Public Library. This will also be discussed at the 11/9/23 Board meeting.

# Recommendation

It is recommended that the Library Board of Trustees President appoint two Trustees to a nominating committee which will be responsible for presenting a proposed slate of officers at the January 2024 Board of Trustees Meeting.

#### Background

Per its Bylaws, the Library Board of Trustees must establish a two-person Nominating Committee each November, and that committee must present a slate of officers for the Board to take action on two months later, at the January Board meeting. The Bylaws also allow for additional nominations to be made from the floor at the January meeting, with the consent of the nominee. The officers elected at the January meeting hold their offices until the following January meeting.

The Library Board of Trustees has three officers: President, Vice President, and Secretary. Following are the duties for these positions, as proscribed by Article II, Sections 2 and 3 of the Bylaws.

- President: Sets the agenda for Board meetings in conjunction with the City Librarian; conduct meetings; appoint committees; perform all duties of the presiding officer; present the annual report to the City Council and have general supervision of matters pertaining to the library.
- Vice President: In the absence of the President from a Board meeting, the Vice-President shall preside.
- Secretary: With the assistance of Library staff, shall post meeting agendas; handle correspondence; and perform such other duties as may belong to the office or as may be delegated by the President or by action of the Board.

There are no limits on the number of times a Trustee may serve as Vice President and Secretary, nor on how many times they may do so consecutively. The Bylaws do, however, prohibit Trustees from serving more than two consecutive one-year terms as President.

#### Discussion/Analysis

The officers currently serving are Dean Serwin (President), Bianca Richards (Vice President), and Annie Chang Long (Secretary).

Because Dean Serwin is finishing his second consecutive year as President, the Nominating Committee will be tasked with identifying a nominee for that office.

Bianca Richards has previously served as President during her current tenure on the Board and is eligible to do so again.

Trustees Kenny Gross, Ed Pearson, and Annie Chang Long are all eligible to serve in any of the three Library Board of Trustee officer positions.

#### Background

This Staff Report provides short summaries of selected highlights from the previous month's Library operations.

# Updates

#### Library Staffing

An offer made to a candidate for the full-time Children's Librarian position has been accepted. The candidate is currently in the background check process. Staff hope to be able to make an announcement introducing our new staff member soon.

Part-time Clerk I Andrea Patlan was promoted to part-time Clerk II. Final interviews for this promotional opportunity were conducted on October 9th. Andrea has been with the Library since November 2020, when she was hired as an Aide. In February 2022 she was promoted to Clerk I. This is a well-deserved promotion. Andrea is currently studying for her Master in Library and Information Science.

#### Library Not Awarded Critical Infrastructure Grant Funds from State Library

On May 11, 2023, the City submitted a grant application to the California State Library for the <u>Building Forward</u> Library Facilities Improvement Program. This was the second round of funding from this program. Round two had \$175 million available to award to eligible capital projects, including addressing critical maintenance needs, improving energy efficiency and sustainability, and expanding access digitally and physically. The State Library received 148 applications with requests totaling over \$482 million. By law, first priority was given to local libraries located in high poverty communities. South Pasadena's proposed project was not selected for funding in this round because South Pasadena was not among the facilities with the highest poverty levels, as determined by the <u>California Poverty Measure</u>. The notification letter from State Librarian Greg Lucas stated that the governor and the Legislature have promised they will allocate an additional \$100 million in Building Forward funds over the next three years, and that those funds will be awarded to support more projects from the Round two application pool. City staff will be revisiting the prioritization and possible funding sources for the

critical repairs and improvements that the library building needs in order to determine next steps.


# **Retro Games Day at the Library**

Free and open to the public, the Bazaar provides a one-stop opportunity to interact with dozens of archives, from large institutions to private collectors.
