Trustee Meeker said she and President Annie Chang Long would like to meet with Friends Board President Kevin O'Neill to discuss the planning for the next Volunteer Appreciation Event and possible co-partnership with the Friends.

Secretary Pearson attended a Zoom conference for United for Libraries, an arm of the American Library Association. He discovered some wonderful ideas for how to support the library during an "Onboarding Trustees" session. This includes fighting the culture wars, supporting Library staff, and advocating for libraries in the community. This may be a Discussion Item for the 10/10/24 Trustees meeting, or future meetings.

Secretary Pearson shared a piece of library trivia: Harvard University's 21 million items take up 57 miles of shelving.

Secretary Pearson read the poem "Where My Books Go," by William Butler Yeats.

Trustee Richards had a great experience with the Tech Help Session at the Library. She observed that Local History Librarian Olivia Radbill handled an incident with a patron very well.

The Friends have engaged a website designer. They will co-sponsor the "All About Birds" event in the Community Room with South Pasadena Beautiful on 9/24/24. The Friends hope to continue building community awareness by partnering with other local non-profits and aligned causes.

Secretary Pearson said he found the "Between Friends" monthly newsletter to be fantastic.

Recommendation

It is recommended that the Trustees receive an update from Library Staff and Library/Community Center Site Plan Ad Hoc Committee member Trustee Bianca Richards about the Site Planning Project and Ad Hoc Committee activity.

Executive Summary

The Site Planning Project will explore the possibility of building a new facility for library and community services on the current site of the Library and Senior Center. The City Council established an Ad Hoc Committee to work with staff and consultants on the project. The Committee is made up of representatives from the Library Board of Trustees, the Community Services Commission, The Friends of the Library, the South Pasadena Senior Citizens' Foundation, City Council, and six At-Large members from the community.

Background

The Ad Hoc Committee had its first meeting on August 1, 2024. Their work to date has included reviewing and providing feedback on the submissions received in response to the Request for Qualifications for a site planning consultant. Based on that review process, three firms were selected to be interviewed:

- Group 4 Architecture, Research + Planning, Inc.
- Johnson Favaro, LLP
- Koning Eizenberg Architecture Inc.

Interviews were held September 24, 2024, with the help of the following panelists:

- Tom Afschar – Member At-Large, Site Plan Ad Hoc Committee
- Janet Braun – City of South Pasadena Councilmember
- Ted Gerber – Director of Public Works (City of South Pasadena)
- John Jones – Community Services Director (retired)
- Bianca Richards – Member At-Large, Site Plan Ad Hoc Committee
- Nikki Winslow – Director of Altadena Libraries

Lucy Hakobian, Deputy Director of Community Services, Melissa Snyder, Community Services Supervisor, and Cathy Billings, Library Director were also present.

The panelists rated the three candidates and put two forward as equally qualified for staff to consider. Staff are currently conducting reference checks and developing a professional services agreement with the firm they believe is best qualified and most likely to work well with the South Pasadena community.

Clerks (part-time)

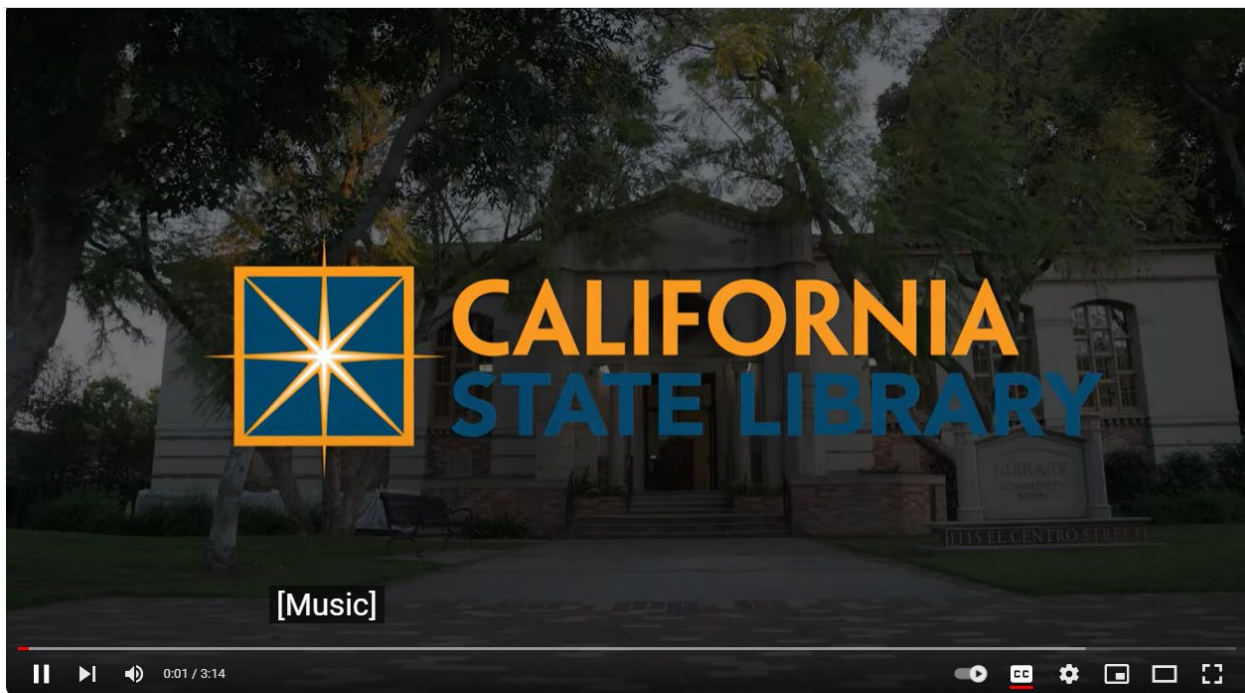

State Library Recognizes Library Staff and their Sowing South Pasadena Initiative

Librarians Alexis Mendoza and Olivia Radbill were praised by the State Library for their exemplary work on their grant-funded Sowing South Pasadena initiative. With the \$22,470 in funding they secured from the State Library, they offered sustainability themed programs and services over several months, including the launch of a Seed Library (more than 2,000 packets given away so far), hosting a Repair Cafe, giving away eco-themed books as Summer Reading Program prizes, and presenting talks by Ed Begley, Jr., Barbara Eisenstein, John Fleming, and Matthew Teutimez, Elder of the Gabrieleño Band of Mission Indians. The State Library produced a short, outstanding video about Sowing South Pasadena and Teutimez' talk, which is well-worth watching!
