TUESDAY, SEPTEMBER 21, 2021 MINUTES OF THE CITY OF SOUTH PASADENA MOBILITY AND TRANSPORTATION INFRASTRUCTURE COMMISSION REGULAR MEETING

CALL TO ORDER

The Regular Meeting of the Mobility and Transportation Infrastructure Commission was called to order by Chair Abelson on September 21, 2021, at 6:39 p.m. The meeting was held in a hybrid manner, both in person and via Zoom.

Commissioner Dunlap requested staff to look into installing a U-turn sign for westbound Huntington Drive at a location closer to Fremont Avenue than Alhambra Road.

Commissioner Fisher commented on what actions are being taken on cleaning up the area surrounding the South Pasadena rock wall sign off of the SR-110 freeway. DPWD Shelleh reported on Chair Abelson's request in this regard and stated that staff is waiting for City Council approval on the West Coast Arborist (WCA) agreement and once approved, he will authorize WCA to clean the area. Chair Abelson concurs with Commissioner Fishers concerns regarding the City of South Pasadena rock sign.

Chair Abelson advised that the City of Pasadena is working with CalTrans on the relinquishment of the SR710 freeway stub area back to the City of Pasadena, which provides hope that streets affected by the stub traffic will be restored to the neighborhoods.

10. Staff Communications

The proposed citywide neighborhood traffic management program is currently scheduled to go to the City Council for approval on 10/20/21.

The SR710/Fair Oaks Interchange RFP Draft is completed and under review. Chair Abelson and Vice Chair Fisher reminded DPWD Shelleh that the scope of the RFP is to be shared with the SR 710 ad hoc committee for review and input, and he advised he would follow up.
