**SUBJECT:** Conditional Approval of Tree Removals at 1865 Hanscom Drive

### Recommendation

It is recommended that the Natural Resources and Environmental Commission (NREC) approve the tree removal replacement plan for 1865 Hanscom Drive.

### **Background**

At the Special NREC meeting, on December 5, 2023, the NREC conditionally approved the tree removals at 1865 Hanscom Drive pending the submittal of a tree removal replacement plan.

### Discussion/Analysis

Attached is the tree removal replacement plan (Attachment 1) submitted by the applicant. Staff discussed the proposed replacement plan with the City Arborist, and after receiving additional information from the applicant, determined that the replacement plan is feasible. The applicant is proposing to plant 39 avocado trees and two sago palm trees on the slope of the property, 10-15 feet apart. The applicant has requested a variance to accommodate smaller replacement trees than the 24-inch box requirement. The property will not be terraced, and trees will be planted on the existing slope manually carried from the driveway to their planting location, hence the variance request (Attachment 2). The applicant will install a chain linked fence at the edge of the lot to protect the properties below on Peterson Avenue.

### **Fiscal Impact**

The applicant has paid the required tree removal inspection fee and will be required to pay any permit fees for the permit, as well as a deposit associated with any tree replacement requirements.



Enclosed please find a plan for "tree replacement" at 1865 Hanscom St.

I have long nurtured thoughts of an avocado groove. This has some benefits:

These trees are actually useful and productive. They have shallow roots which

mitigate soil erosion. While the trees can be up to 40 feet, they produce better if

regularly trimmed. I would anticipate keeping them at 10 feet or less. They will therefore not interfere with views or electrical wires. When the lot is eventually built out, gray water

will be available to maintain them.

I would like to replace the Trees of Heaven at the base or the driveway with two nice Sago Palms I have at home in pots.

I need to request two variances. The lot is quite steep and carrying down large 24x24 pots would be quite onerous. The drop from the bottom of the driveway to the "groove" will be about 60 feet. Please allow me to use plants we can carry down. Avocados like to be planted in the Spring, so you may allow me some extension on the 60 day requirement.

I am sorry to deprive the neighborhood of the quality trees they have grown to love but maybe I can substitute quantity for quality.

Thank you for your continued help on this project.

SUBJECT: Appeal of a Decision of the Public Works Director for the Required

**Replacement Trees** 

### Recommendation

It is recommended that the Natural Resources and Environmental Commission (NREC) review a property owner's appeal of the decision of the Public Works Director for required replacement trees.

### **Background**

On September 12, 2022, the City was notified of possible illegal tree removals at 2054 Fremont Avenue. City staff conducted an inspection and reported unpermitted tree removals.

### Discussion/Analysis

Per South Pasadena Municipal Code (SPMC) Chapter 34.3a it is unlawful for any person to remove or transplant any significant or mature heritage tree, a significant, or a mature native species tree, or a significant mature Oak tree from any property within the City unless a tree removal permit is first obtained from the City. It was determined during the inspection, that 13 palm trees were removed from the property.

Per SPMC Section, 34.12a penalties for any person who unintentionally violates the provisions of this chapter shall be as follows:

- the standard inspection fee
- double the required tree removal or trimming permit fee
- planting double the number of replacement trees required pursuant to section 34.12-5 -

The property owner submitted a written response (Attachment) explaining the reason for the tree removals and has requested an appeal to reduce the number of required replacement trees.

### **Fiscal Impact**

The penalties assessed for the illegal removals total \$826 (Inspection fee and double permit fee). The required number of replacement trees are 22. Per SPMC 34.11(b) (2) if the subject property cannot accommodate multiple trees, alternative location within the city (public right-of-way, park, etc.) may be designated.
