Approval of Minutes – Meeting of March 22, 2022

CITY OF SOUTH PASADENA NATURAL RESOURCES AND ENVIRONMENTAL COMMISSION – REGULAR MEETING MINUTES – March 22, 2022

CALL TO ORDER:

The meeting was called to order at 7:10 p.m. Present at the time of roll call were: Commissioner Michelle Hammond, Commissioner Casey Law, Commissioner William J. Kelly, and Chair Amy Davis Jones. Commissioner Rona Bortz was absent. Mayor Michael Cacciotti arrived at 7:55pm. Commissioner Michael Siegel had an excused absence. Staff present: Ted Gerber, Public Works Director and Arpy Kasparian, Environmental Services & Sustainability Manager.

1) GENERAL PUBLIC COMMENT

Wes Reutimann, Special Programs Director with Active San Gabriel Valley - Shared the return of 626 Golden Streets in South Pasadena, May 1, 2022. A series of activities will be taking place during the event: electric bike demonstration, live entertainment, activities for kids, and a series of informational booths. Reutimann offered a booth to the Commission during the event to raise awareness for ongoing initiatives and upcoming events.

2) Earth Day Events in South Pasadena

Kasparian shared a series of events to highlight Earth Day 2022 in the City. There will be promotion on current City programs such as water conservation rebates, water waste reporting, and the Clean Power Alliance. The commissioners discussed how they could participate in the events.

7) <u>City Council Liaison Communications</u>

Mayor Cacciotti visited the Gold Line Extension Construction Authorities project in Glendora. The Santa Monica Mountains Conservancy is discussing possible pedestrian bridges and bike trails. Cacciotti is also attending meetings with SCAQMD to conduct studies for improving air quality.

8) Commissioner Communications

Commissioner Kelly urged that water conservation be taken seriously because the State of California is not meeting voluntary measures in place. Commissioner Law shared that The IPCC 6th assessment report is accessible at the website IPCC.CH and discusses climate change impact. Commissioner Hammond shared residential questions about tree planting and tree replacement watering tips on the parkway.

Kasparian shared the Senior Citizen Dumpster Day and thanked Chair Jones for her service with the NREC. Ted Gerber also thanked Chair Jones and congratulated the new Chair and Vice Chair. Gerber shared an update on stormwater projects.
