CITY OF SOUTH PASADENA NATURAL RESOURCES AND ENVIRONMENTAL COMMISSION – SPECIAL MEETING MINUTES – January 25, 2022

CALL TO ORDER:

The meeting was called to order at 7:01p.m. Present at the time of roll call were: Commissioner Rona Bortz, Commissioner Casey Law, Commissioner Bill Kelly, and Commissioner Michael Siegel. Commissioner Michelle Hammond had an excused absence. Mayor Michael Cacciotti was present. Staff present: Ted Gerber, Public Works Director; and Arpy Kasparian, Environmental Services & Sustainability Manager.

Gerber discussed the commission analysis and possible changes to the development of the Work Plan and its alignment with the City's Strategic Plan. Gerber reviewed the actions and goals of the Strategic Plan that would tie into the commission's work plan. The commissioners discussed what they would like to see in the upcoming work plan and expressed desire to go beyond the strategic plan to include items such as water conservation and education and plastic reduction.

Gerber recommended that the commission postpone the selection of officers in the event that the commission analysis changes the structure of the commission. The commission agreed.

6) <u>SB1383 & Food Scrap Collection Update</u>

Kasparian provided the commission with an update on the progress of SB1383 implementation. Commissioner Kelly provided an update on the options the Athens' Ad Hoc Committee is discussing. Kasparian informed the commission of staff's pursuit of a grant to assist with SB1383 implementation and provided information on the residential food scrap collection program in the City. The commission asked questions and discussed several aspects of SB1383 implementation including collection, reporting, SB619, and education & outreach.

7) <u>City Council Liaison Communications</u>

Mayor Cacciotti updated the commission on the meetings he attended and elaborated on the commission analysis. He shared new practices he will be implementing as mayor.

Commissioner Bortz had no comments. Commissioner Kelly updated the commission on the Leased Facilities Ad Hoc Committee and requested a presentation on the Arroyo stormwater projects. Commissioner Siegel had no comments. Commissioner Law updated the commission on City plans for heat emergencies and encouraged the involvement of a CERT group in the City. Chair Jones shared support for Commissioner Kelly's request for a presentation on stormwater projects.

9) <u>Staff Liaison Communications</u>

Kasparian reminded the commission of the commission survey and workshop and informed them that staff will be recommending City Council to upgrade the commercial default power service from 50% clean energy to 100% green energy. Gerber provided additional updates on the City's electrification projects and on the Arroyo Seco project.



Purpose Statement

The Natural Resources and Environmental Commission (NREC) is a seven member body that is advisory to the City Council in all matters pertaining to energy, science and technology, and natural resources and the environment. The NREC assists the City in the planning, programming, use, and conservation of energy and natural resources, as well as administers the City's tree ordinance. Qualifications for serving on the commission consist of being a resident elector (registered voter) of the city. Members are appointed to a three-year term, with a maximum length of service of two full consecutive terms, plus one partial term (if applicable).

NREC meetings are held every fourth Tuesday of the month at 7:00pm. Meetings are held at the City Council Chamber: 1424 Mission Street. Due to COVID-19 safety protocols, Commission meetings were held virtually in the beginning of the year and in a hybrid mode since July 2021.

2021 Accomplishments

Virtual Earth Day

In 2020, the COVID pandemic shut down plans for a 50th celebration of Earth Day. In 2021, the commission celebrated remotely by sending the community messages on what makes the City so inspiring for them, by launching the new South Pasadena Tree Guide, and by creating a video that illustrated how easy it is to get around town without a car.

Mandatory Organics Recycling Ordinance

Per Senate Bill 1383, jurisdictions are mandated to provide organics collection services and require all residents and businesses to divert organic waste from landfills. The NREC received several presentations, conducted thorough discussions, and recommended a Mandatory Organics Recycling Ordinance to City Council which was ultimately adopted in 2021.

Recommendation of Tree Ordinance

Per the 2019 adopted Green Action Plan, the NREC reviewed and provided a recommendation for the amendments to Chapter 34 (Trees and Shrubs) of the South Pasadena Municipal Code. These amendments aim to strengthen the Code to reflect the City's goal of protecting and maintaining a healthy tree canopy.

Ordinance Banning Gas-Powered Leaf Blowers

Per the Climate Action Plan and the Green Action Plan, the NREC discussed and recommended to Council an ordinance prohibiting the use of gasolinepowered leaf blowers in the City. Emissions from gas-powered lawn equipment including leaf blowers are a significant source of air and noise pollution in our community and can have severe impacts on the health of gardeners and landscape workers. With Council's ultimate adoption of the ordinance, the City is taking another step towards a cleaner and more sustainable community.

Review of City Cool Roof Codes

The commissioners were joined by several building officials from Transtech Engineers to review the City's cool roof requirements. The commission asked questions and engaged in discussion regarding how cool roofs affect the urban heat island, the feasibility of adopting more restrictive cool roof codes than the state, and the alternative of offering incentives for cool roof installations rather than seeking approval for an upgraded code. Per the Green Action Plan, the commission will continue to investigate ways the City can implement practices that mitigate urban heat.
