

Purpose Statement

The Natural Resources and Environmental Commission (NREC) is a seven-member body that is advisory to the City Council in all matters pertaining to energy, science and technology, and natural resources and the environment. The NREC assists the City in the planning, programming, use, and conservation of energy and natural resources, as well as administers the City's tree ordinance. Qualifications for serving on the commission consist of being a resident elector (registered voter) of the city. Members are appointed to a three-year term, with a maximum length of service of two full consecutive terms, plus one partial term (if applicable).

FY22-23 Accomplishments

Review of Current Parking Lot Codes

The commissioners were joined by the City's Planning Manager to review the City's current parking lot code. The commission asked questions and engaged in discussion regarding how parking lots affect the urban heat island and the feasibility of adopting more restrictive parking lot codes. The commission also reviewed current landscaping requirements. Per the Green Action Plan, the commission will continue to investigate ways the City can implement practices that mitigate urban heat.

Single-Use Plastics Discussion Kick-Off

The commission discussed possible restrictions to single-use plastics in the City. The commission motioned to further agendize the discussion and consider the formation of a taskforce to address plastic-free initiatives in the City.

Athens Materials Recovery Facility (MRF) Tour

As the City works to amend the current exclusive franchise hauler agreement to accommodate the requirements of Senate Bill 1383, the commissioners are committed to learning more about the waste hauling process. Over two tours, four commissioners joined City and Athens staff to tour the Sun Valley Materials Recovery Facility (MRF) where they witnessed firsthand how state-of-the-art technology is used to maximize recyclables recovery and landfill avoidance.

Continued Monitoring and Guidance for Green Action Plan and Climate Action Plan Implementation

The commission continues to receive periodic updates from staff on the progress of the implementation of the City's Green Action Plan and Climate Action Plan. The commission provides guidance and insight on the various actions outlined in the plans.

ITEM 4

Approval of Minutes –Meeting of April 25, 2023

CITY OF SOUTH PASADENA NATURAL RESOURCES AND ENVIRONMENTAL COMMISSION – REGULAR MEETING MINUTES – April 25, 2023

CALL TO ORDER:

The meeting was called to order at 7:03 p.m. Present at the time of roll call were: Chair Ella Hushagen, Vice Chair Michael Siegel, Commissioner Rona Bortz, Commissioner Michelle Hammond, Commissioner Amy Davis Jones, and Commissioner Richard Tom. City Council Liaison Councilmember Michael Cacciotti was absent from the meeting. Commissioner Casey Law had an excused absence. Staff present: Ted Gerber: Public Works Director, Arpy Kasparian: Environmental Services & Sustainability Manager, Melanis Stepanian: Water Conservation & Sustainability Intern, and Mark Jimenez: Management Analyst.

1) General Public Comment

There were no general public comments.

PUBLIC HEARING:

2) <u>Continued Tree Hearing</u> – 1865 Hanscom Drive

Commissioner Tom asked if the chain link fence is meant to be permanent. Commissioner Jones questioned how the chain link fence would mitigate erosion and gave alternative suggestions for erosion mitigation. Commissioner Bortz brought attention to the non-native tree species selected by the applicant. Commissioner Hammond asked the applicant why they chose avocado trees. Commissioner Jones shared her concerns regarding the placement of the trees. Chair Hushagen asked if the applicant looked into planting the replacement trees at an alternative location.

PUBLIC COMMENT

Janet Sedgwick discussed the steep ground and her concerns about the dirt on the property being dug up and eroding.

Angelo Gladding shared his concerns regarding the proposed choice of avocado trees on the property. He suggested taking advantage of native trees on the property to help retain water.

MOTION BY COMMISSIONER TOM, SECOND BY COMMISSIONER HAMMOND, MOTION CARRIED 6-0, TO DENY THE TREE REMOVAL PLACEMENT PLAN AT 1865 HANSCOM DRIVE WITH UPDATES TO THE PLAN INCLUDING TREES THAT WILL ESTABLISH QUICKLY, ARE DROUGHT TOLERANT, AND WILL REDUCE EROSION. COMMISSIONERS REQUESTED FOR THIS ITEM TO BE BROUGHT BACK TO A FUTURE MEETING.

3) <u>Tree Hearing</u> – 2054 Fremont Avenue

The property owner requested ease of penalty for the removal of trees without a permit.

PUBLIC COMMENT

No public comments.

MOTION BY COMMISSIONER JONES, SECOND BY COMMISSIONER TOM MOTION CARRIED 6-0, TO DENY THE APPEAL FOR THE PROPERTY OWNER AND REQUIRE REPLACEMENT TREES OR RESPECTIVE FINES TO BE PAID.

4) <u>Review of FY22-23 Water Conservation Program</u> – Arpy Kasparian, Environmental Services & Sustainability Manager

Kasparian shared a review of the water conservation program within the City and reviewed the various rebates available. Rebate information regarding both City and Metropolitan Water District Rebates can be found at <u>SouthPasadenaCA.gov/WaterConservation</u> or <u>SouthPasadenaCA.gov/Rebates</u>.

Commissioner Tom asked for specific statistics that display how much water is saved by utilizing water conservation tools, such as high-efficiency dishwashers or toilets. Commissioner Tom also suggested promoting specific rebates to commercial businesses to increase participation.

Chair Hushagen had no communications. Commissioner Jones encourages residents and businesses to take advantage of the rebates available. Vice Chair Siegel discussed working on the "low-hanging fruit" and more feasible steps within Climate Action Plan, especially with an update coming soon. Vice Chair Siegel also promoted the free bike valet at the City's Eclectic Festival and the May bike bus which will be the last of the school year. Commissioner Tom had no communications.

Ted Gerber, Public Works Director, shared about the April 26 Special Joint Meeting of the City Council and Mobility, Transportation & Infrastructure Commission discussing the State of the Streets.

Arpy Kasparian, Environmental Services & Sustainability Manager, updated the commission on Earth Day events and reminded Commission members to bring their ideas to the table as a new work plan discussion will be brought to a future meeting.
