CITY OF SOUTH PASADENA NATURAL RESOURCES AND ENVIRONMENTAL COMMISSION – REGULAR MEETING MINUTES – September 22, 2020

CALL TO ORDER:

The meeting was called to order at 7:02p.m. Present were: Commissioner Amy Jones, Commissioner Bill Kelly, Commissioner Stephen Leider, Vice Chair Rona Bortz, and Mayor Pro Tem Diana Mahmud. 2) Energy Efficiency Resources – San Gabriel Valley Council of Governments

Alexander Fung gave a presentation on the San Gabriel Valley's background, their Energy Wise Partnership which provides incentives for cities' direct energy savings, their partnership activities and resources for local governments, and the Energy Champion Awards. Fung also provided information on energy efficiency programs for residents and businesses and reviewed a few energy efficiency tips.

3) Second Reading of Tree Ordinance

Crawford walked through the Tree Code and reviewed the changes made per the commission's requests from the previous meeting. The commission further discussed additional changes including adding language to clarify tree permit requirements for non-native trees, ensuring parkway trees were addressed, changing the headings for 34.6 and 34.10, and ensuring that the appropriate fine was issued depending on the size and scope of the project. In addition to changes to the tree code, the commission and Crawford discussed a map of heritage trees in the City, ensuring that replacement trees were appropriate, adjusting the timeline of when the commission and Public Works reviewed development plans so that they are reviewed in the earlier stages and open to more guidance, and including examples of fines in the permit to give applicants an idea of how severe the penalty could be.
