Commissioner Kelly shared concerns from residents regarding the CAP survey including that the survey was very long, it was difficult to assess what was important, and there were concerns over cooking with a wok on electric stoves. Commissioner Myles had no comments. Vice Chair Bortz had no comments. Chair Di Giorgi encouraged residents to comment during the August 5<sup>th</sup> City Council meeting.

Kasparian provided an update on what the City is doing to re-enforce the Plastic Bag Ban including publishing an article on the City blog and the Chamber newsletter. Most grocery stores are resuming pre-Covid plastic bag practices. Kasparian provided an update on the Climate Action Plan and survey participation.
