We are especially grateful that the construction truck haul route will not include Meridian Avenue. You may still wish to add a cross-reference to PW20 permit condition with P13.a permit condition so that there is no misunderstanding later on.

Bonita Drive residents continue to be concerned about the geotechnical aspects of the proposed project and will provide their separate comments to you.

SMART Families therefore have no further comments on this project and hope that the applicant and contractor will act as good neighbors by complying with all permit requirements.
