We write this letter in support of My KKids' application for a conditional use permit.

We have entrusted My KKids with the care of our only daughter Lucía ever since she started attending school in person last year. She is now in second grade.

At a time when we were full of anxiety about sending our child to school and after care, the administration and staff at My KKids helped put us at ease.

As an Investigator at the Federal Public Defender's Office, I am well aware that there are irresponsible and dishonest people with ill intentions in the world, which is why there are only a handful of people that we trust enough to care for Lucia, much less drive her. Still, we trust My KKids to keep her safe. They are responsible, responsive, and nurturing.

South Pasadena has dismayingly few options for after school child care, which is essential for families where all the adults in the home have full time jobs. We are appreciative that we have My KKids to watch Lucía after school; we have no other options of where to send her.

Who knows where we'd be without My KKids, but I certainly would hate to find out. Please ensure that Lucia and the rest of children who go to My KKids continue to be well cared for by approving their permit application.
