SUBJECT: Approval of the Fused Glass and Metal Sculpture for the Proposed

Project at 1611 Spruce Street (APN: 5320-009-022)

Recommendation

It is recommended that the Commission review and approve the fused glass and metal sculpture for the proposed project at 1611 Spruce Street.

Discussion/Analysis

The proposed project, titled "Birds in Light" by Tim Carey and Cristopher Slatoff, includes the installation of sculpture comprised of five (5) Red Crowned Parrots in flight around a tree. The sculpture will include fused glass inserted into metal sculpture, resting on a plinth, and will be four feet in height. The sculpture can be placed on a pedestal or bird bath.

| Will the proposed artwork be sited without interference from commercial signage? | Yes, there is no commercial signage within the vicinity of the proposed project. |
| Were the structural plans reviewed by the City's Building and Safety Division to determine if a Building Permit is required? | The City's Building and Safety Division have reviewed the plans, the proposed project consists of a 4-foot sculpture that can be placed on a pedestal or bird bath, there is no construction associated with the proposed project, and no building permits are required. An electrical permit will be required for the proposed lighting. |

| Will the proposed artwork be appropriately lighted? | Yes, the proposed sculpture will be lit by a lighting fixture placed on or near the base of the sculpture from the pedestal. The light will spread up and out to cover the width of the glass sculpture at night. |
| Does the developer/property owner have a recorded maintenance plan to ensure ongoing, permanent maintenance to preserve the artwork in good condition? | Yes, the primary materials will require little to no maintenance beyond periodic dusting. In accordance with Section 36.395.080 Ownership and Maintenance Cost of On-Site Public Art of Ordinance No. 2325 Public Art Program the obligation to provide all maintenance to preserve the artwork in good condition will remain with the owner of the site; and prior to placement of an approved artwork, the applicant and owner of the site shall execute and record a covenant in a form approved by the City for maintenance of the artwork. |
| Is the proposed artwork mass-produced with a standard design, reproduction of original artwork, signage, decorative/ornamental elements of functional components of a building designed by the architect, historic/architectural elements of a building façade, or landscape gardening? | No, the proposed project is a new one-of-a-kind piece of art and is not mass produced with a standard design. |
| Is the proposed artwork responsive and relevant to the site (its history, architecture, development, landscaping, and socio-economic context)? | Yes, the proposed project represents the Red Crowned Parrots that live and roam throughout the City of South Pasadena. |
| Does the proposed artwork encourage local artistic endeavors, public dialogue, and interactions with art in public places? | Yes, the proposed project will be readily accessible to the general public within the vicinity of 1611 Spruce Street. |

| Does the proposed artwork support a public art collection that includes works of various genre, style, scale, media, form, and intent that is reflective of contemporary public art practice that spans local, regional, national, and international levels? | Yes, the proposed project utilizes glass techniques practiced by Mr. Carey and metal sculpture by Mr. Slatoff to provide an excellent addition to a well-rounded public art collection. Fused glass is a very contemporary art form, but is still related to the more traditional stained glass medium which is commonly utilized in public artworks around the world. |
| Does the proposed artwork advance the commissioning of artwork throughout geographic areas of the City? | Yes, the proposed project will be added to the City's inventory of public art and is located in an area that does not currently contain public art. |
| Does the proposed artwork demonstrate a collaborative approach to the project by a design team that includes the selected artist(s) project architect(s), landscape architect(s), and other design professionals? | Yes, the proposed project compliments the residential redevelopment project at 1611 Spruce Street. |
| Does the selected artist work in the public realm, and have relevant past experience with proven technical and aesthetic ability to successfully create artwork responsive to the site and community? | Yes, Mr. Carey worked on churches and the Disney theme parks in Anaheim, Shanghai, and Tokyo; and Mr. Slatoff has worked on public monuments at numerous universities and churches that are accessible by the public |
| Does the selected artist have the highest artistic merit, sensitive to the City's cultural diversity, and can contribute to the characteristics and unique expressions of the City's values? | Yes, Mr. Carey has worked as the lead artist on numerous projects at The Judson Studios including the 3,400 square foot "Resurrection Window" at the United Methodist Church of the Resurrection in Kansas; and Mr. Slatoff is the Sculpture Chairman of the California Art Club and has sculptures at Our Lady of Angeles, Nuestra Senora Reina de Los Angeles, and USC Caruso Catholic Center. |
| Is the proposed budget sufficient to produce the proposed artwork? | Yes, the proposed project will be completed by Mr. Carey and Mr. Slatoff for a total cost of \$6,000. This includes \$1,200 for design, \$1,200 for glass fabrication, and \$3,600 for metal fabrication. |

Background

On June 5, 2019, the City Council adopted Public Art Program Review Criteria. On November 21, 2019, the Cultural Heritage Commission approved the Certificate of Appropriateness for a 2,516 square-foot addition to an existing 3,008 square-foot home, a 90 square-foot addition to the existing garage, and construction of a new subterranean garage for 13 cars. The total building valuation is estimated at \$594,000. The one percent Public Art Allocation is equal to \$5,940.






Fused Glass inserted into metal sculpture, resting on a plinth. Could rest on a pedestal or a bird bath.

Those of us who have the great fortune of living in South Pasadena are all familiar with the sounds of the ever present Red Crowned Parrots. They come like a rushing wind, and on these rare occasions when they are still, we have the ability to marvel at their beautiful bodies, coated in feathers ranging from greens to reds and ambers.

What better way to represent these beautiful birds then a sculpture, capturing them in action, using colored glass and metal. Fused glass is a technology that is relatively new, and in the last 4 years, South Pasadena artist Tim Carey has been manipulating and painting with the glass itself to create beautiful, painterly areas of light and color.

Combining this material with the metal sculpture of renowned California sculptor Christopher Slatoff makes for a unique opportunity to create an original art piece that South Pasadena can be proud of.

Scope of Work: Design and fabricate Art Glass Sculpture for entrance of apartment complex

Dear Mr. Agius,

We, Tim Carey Studio, do hereby agree to complete the aforementioned project for the total cost of \$6,000.00 This proposal is good for Ninety (90) days.

I.- This sculpture shall be made in accordance with the most up to date and accepted traditions of this craft. The glass shall be fused, and carefully annealed. All craftsmanship and materials used to complete this commission shall be of the highest quality available. Any requests contrary to this policy will be reviewed and are subject to additional charges. Once final designs have been approved, any changes or alterations thereafter requested by client are subject to additional charges of One Hundred Fifty (\$150.00) per hour. Work on the project will commence once accurate field measurements are obtained or supplied to Tim Carey Studio and this proposal has been signed and returned with initial payment.

II- Sculptural design and Fabrication will be executed by Christopher Slatoff, of Los Angeles, Ca

Tim Carey Studio and Christopher Slatoff reserve the right to photograph, film and publicize the finished product in all media for archival and marketing purposes.

III- Tim Carey Studio carries general liability insurance, protecting the owner against possible injuries to persons or property, which may flow from this work.

IV- Payments shall be made as follows: 50% of the total sum due and payable upon approval of this proposal; progressive invoicing during fabrication in 2 payments of 25% apiece. The final payment (25%) shall be due and payable upon the installation of the project. Design fees will be applied to overall cost of project. All invoices, after initial payment, are due and payable upon receipt and will be considered delinquent if not paid within 15 days of invoice date. We reserve the right to impose a service charge of 1.5% per month on all delinquent accounts. All deposits received are nonrefundable, but will be available for credit for future projects, should refunds be sought.

V- Project phases and timetables

- 1. Design submittal- Tim Carey Studio (TCS) will submit final designs within 2 calendar weeks after receipt of signed contract and initial deposit of 50%.
- Revisions- Serene Land LLC will be allowed up to two (2) design revisions. Each design revision will be completed within one(1) calendar week of receipt of notes/comments/ changes.
- 3. Glass and Sculpture fabrication- TCS will commence with all artwork associated with crafting and fusing the glass and metal sculpture per approved design. Total sculpture fabrication time 6 weeks. 25% progress payment due at completion of glass fabrication.
- Glazing and Install- Glass panels will be glazed and installed by TCS and Christopher Slatoff. Total glass fabrication and installation time 4 weeks from receipt of glass from TCS.

Discussion/Analysis

The Art Resources Inventory (Inventory) was established to identify existing art resources and potential gaps and opportunities. The Inventory will help the Commission formulate more well-informed decisions on future projects and programing. The Commission has done a good job of helping populate the Inventory; however, there may be additional resources that have not been identified. In order to ensure we have a clear representation of all of the arts resources in the City, staff would recommend

Background

On October 17, 2018, the City Council approved the creation of the Public Art Commission for the purpose of reviewing and approving public art projects associated with the Public Art Program, including but not limited to, proposed site-specific public art, art donations, and public art developed with the funds from the Public Art Development Fee.

Public Notification of Agenda Item
