CALL TO ORDER

A Regular Meeting of the Public Safety Commission was called to order by Chair Ding on Monday, February 8, 2021, at 8:34 a.m., in the Amedee O. "Dick" Richards, Jr., Council Chamber, located at 1424 Mission Street, South Pasadena, California.

PUBLIC COMMENTS AND SUGGESTIONS

1. RESIDENT JOSH ALBREKTSON, is concern that some people at the park are not using masks during this pandemic. He believes that the City of South Pasadena should enact a mask ordinance in order to protect people who are being responsible and wearing a mask. He expects the South Pasadena Police Department to enforce the mask ordinance.

2. Selection of Chair for a one year term for 2021

MOTION TO NOMINATE AMIN ALSARRAF FOR CHAIR BY COMMISSIONER DING, SECOND BY COMMISSIONER CAO, carried 6-0 to approve Amin Alsarraf as Chair.

3. Selection of Vice-Chair for a one year term for 2021

MOTION TO NOMINATE STEPHANIE CAO FOR VICE-CHAIR BY CHAIR ALSARRAF, SECOND BY COMMISSIONER DONNELLY, carried 6-0 to approve Stephanie Cao as Vice-Chair.

ACTION/DISCUSSION

4. Minutes of the Public Safety Commission Meeting of January 11, 2021

MOTION BY CHAIR ALSARRAF, AND SECOND BY, COMMISSIONER CAO, CARRIED 6-0, to approve the Minutes of the January 11, 2021 Public Safety Commission Regular Meeting with one change, to add Commissioner Cao to the roll call list.

5. Community Forum for Chief of Police

Interim Police Chief Solinsky informed Commissioners that the City Manager would like for the Public Safety Commission to host a Community Forum on the selection of the New South Pasadena Police Chief. The Forum will give community members an opportunity to provide comments, highlight the characteristics and skills that they believe are important in the representation of leadership for The South Pasadena Police Department. The forum would take place in Zoom format taken into consideration the situation we are currently in, but that would be in discussion with the Commission.

PUBLIC COMMENT; RESIDENT BILL KELLY would like to request that the public be engage in the hiring process for the New Police Chief to make recommendations for the best candidate.

6. <u>Unarmed Traffic Enforcement</u>

Interim Police Chief Solinsky stated that the City Council directed the Public Safety Commission to investigate for potential Unarmed Traffic Enforcement. Community groups have come forward with recommendation for the Public Safety Commission to look at this.

MOTION BY CHAIR ALSARRAF, AND SECOND BY COMMISSIONER LIU KUNG, CARRIED 5-0, to approve the creation of a Subcommittee with Commissioner Donnelly and Commissioner Watson to look at the Unarmed Traffic Enforcement issue and make recommendations to the Commission.

Commissioner Ding Opposed.

7. OTS Grant Letter of Support

Interim Police Chief Solinsky states, The Police Department is seeking Office of Traffic Safety Grant that we seek every year, and it is to provide additional funding and tools for traffic enforcement purposes. The Purpose of the OTS grant is to reduce traffic injuries, fatalities and other traffic related offences that endanger the community. The Police Department is looking into implementing 10 items under the OTS grant. The Police Department is asking for a total of \$108,908.31 from the state. To comply with these 10 areas The Department is looking at personnel cost of \$59,440.00, and in additional cost for service station \$49,468.00 which is a surveyor to reconstruct traffic collisions, fatalities and accidents with major injuries. The Police Department is asking for the Public Safety Commission support in signing the attached letter.

MOTION TO ENDORSE AND REQUEST THE CHAIR TO SIGN THE LETTER OFFICE OF TRAFFIC SAFETY GRANT BY COMMISSIONER DING, SECOND BY COMMISSIONER DONNELLY, carried 6-0 to have the Chair sign the letter Office of Traffic Safety Grant.

COMMUNICATIONS

1. City Counsel Liaison Communications

City Council Liaison Primuth stated he was delighter he was appointed by the City Manager. There has been a lot of issues and interesting things and the biggest decision making is the selection of the New City Manager, the process is a lot of community outreach and we are very optimistic we will be able to get a very talented City Manager.

2. Staff Liaison Communications

Fire Chief Riddle wanted to start with a follow up from the last meeting about a question Mayor Mahmud had regarding senior database whether that was still in place. Chief Riddle did check and the database was still there and he along with Sheila Pautsch will work on updating the information. Also an update that the Fire Department received a notification of approval of MeasureB grant money, they had applied early last year in 2020 with Covid-19 there was a delay in the selection process in the distribution of the funds we have approval for \$94,000 from Los Angeles County. The money will be used for one cardiac monitor, one automatic CPR machine, and two new gurneys that will go in our front line reserve ambulance. Covid-19 Responses dropping a little bit in the county, our call load has also dropped and hospitalization cases are also dropping. To date the entire Fire Department has received their first and second Covid-19 vaccine and the Police Department have received their first dose and are waiting on their second dose.

Interim Police Chief was sad to inform the passing of Police Dispatcher Bayron Salguero who passed away earlier this month from Covid-19 complications. The Police Department will attempt to increase our patrol fleet taking into consideration the cities plan for green fleet we are looking into leasing new vehicles from Enterprise Rent a Car they have a division of fleet vehicles and we will be looking into leasing hybrid cars in

the near future. He also reported that the city has seen an increase catalytic converter thefts.

3. Commissioner Communications

Commissioner Donnelly would like welcome our New Commissioners and our new liaison, and thank Commissioner Ding for his service as Chair last year. Also thank Stephanie and Amin for stepping up and leading the commission this year, and thank Grace for being there today.

Commissioner Liu Kung updated that a new framework from the state to reopen schools. Elementary schools may proceed with the reopening when the case rate of the county is at or below 25 cases per 100k people per day for at least 5 consecutive days. Recently the County Department of Public Health announced that the adjusted case rate is expected to be at or below 25 cases per 1000 by Tuesday February 16, once the County meets the thresh hold the district is anticipating opening in person instruction for preschool to 2nd grade. Tomorrow Feb 9th the school board will review the new state and county criteria and discuss the reopening and a revised reopening date.

Commissioner Ding would like to welcome the new Commissioners and thank Amin and Stephanie for stepping up for Chair and Vice-Chair and welcome our New Council Member Liaison.

Vice-Chair Cao would like to welcome and thank everyone and would also like to thank the Chiefs and staff for keeping the community safe.

Commissioner Watson wanted to thank everyone for welcoming her and she really appreciates being at the commission.

Chair Alsarraf wanted to welcome Commissioner Watson and Angelats, and wanted to thank Commissioner Ding and Liu Kung for their service in the Commission last year. Welcome Liaison Primuth and a lot interesting things that are happening with the current time. Thank you Chief Riddle and Solinsky for your work and your teams work for the past year.



- Path Metro Team (LASD) (No cost to City)













Outreach Frequency

- SPPD HOPE: Weekly.
- WSGV MET: Three times a month.
- Pasadena Union Station Coordinated Entry System (CES) Housing Navigation: weekly.
- Los Angeles Homeless Service Authority's (LAHSA) Homeless Engagement Teams: Weekly/Bi Weekly
- Path Metro Team (People Assisting The Homeless Metro): 5 Days a week.
- It not uncommon to have multiple engagements with the same homeless individual by different outreach teams. This helps to build a rapport and trust, eventually accepting resources. Although, some homeless do not want assistance no matter how often help is offered.
- Grassroots organizations also assist our city's unhoused
