

## **BACKGROUND**

- SOLVABILITY FACTORS ARE USEFUL BECAUSE THEY PROVIDE A FRAMEWORK FOR DETERMINING THE LIKELIHOOD OF SOLVING A CRIME. THESE FACTORS ARE OFTEN BASED ON VERIFIED DATA, STATISTICAL ANALYSIS, AND INVESTIGATIVE EXPERIENCE
- IT IS IMPORTANT TO NOTE THAT SOLVABILITY FACTORS ARE NOT ABSOLUTE GUARANTEES OF SUCCESS, AND INVESTIGATIONS CAN STILL YIELD UNEXPECTED OUTCOMES
- NUMEROUS POLICE DEPARTMENTS ACROSS THE COUNTRY HAVE IMPLEMENTED SOLVABILITY PROGRAMS. THEY CONTINUE TO ASSESS AND REFINE THEIR UNDERSTANDING OF SOLVABILITY FACTORS TO ENHANCE INVESTIGATIVE PRACTICES
  - (ALHAMBRA CA, FULLERTON CA, SAN JOSE CA, DELANO CA, EL CAJON CA, MARINA CA, LA PALMA CA)



## OUR OBJECTIVE

- IMPLEMENTING A SOLVABILITY FACTOR PROGRAM WILL CREATE A SYSTEMATIC AND UNBIASED CASE EVALUATION PROCESS TO BEST UTILIZE INVESTIGATIVE RESOURCES
- REDUCES NUMBER OF CASES W/ MINIMAL INVESTIGATIVE LEADS FOR DETECTIVES TO FOCUS ON CASES W/ SIGNIFICANT INVESTIGATIVE LEADS, INCREASING THE PROBABILITY OF AN ARREST/PROSECUTION
- A SOLVABILITY FACTOR PROGRAM WILL ALSO EXPEDITE THE INVESTIGATIVE REVIEW PROCESS OF ACTIVE CASES TO BETTER SERVE THE COMMUNITY



## **PROCEDURE**

- SOLVABILITY FACTOR CASES WILL ONLY BE APPLICABLE TO PROPERTY CRIMES
- ALL CRIMES AGAINST PERSONS CASES WILL CONTINUE TO BE ASSIGNED TO DETECTIVES BY A DETECTIVE SUPERVISOR
- CRIME ANALYSIS WILL REVIEW PROPERTY CRIME CASES TO DETECT M.O., SERIES CRIMES, RETAIL THEFT GROUPS
- PROPERTY CRIMES CAN THEN BE ENTERED INTO THE SOLVABILITY FACTOR SCORING PROCESS



## **PROCEDURE**

- SCORES THAT DO NOT MEET THE SOLVABILITY THRESHOLD WILL BE ADMINISTRATIVELY CLOSED
- 6 MONTH PILOT PROGRAM. A REVIEW OF THE PROGRAM SHALL BE CONDUCTED TO DETERMINE ITS EFFICACY AND PRACTICALITY
- ALL CASES THAT WERE ADMINISTRATIVELY CLOSED PURSUANT TO THE PILOT PROGRAM CAN BE IDENTIFIED AND REOPENED IF NECESSARY
- CASES MAY BE ASSIGNED AT SUPERVISOR'S/DETECTIVE'S DISCRETION
- A LETTER/NOTICE WILL BE SENT TO THE VICTIM BY A DETECTIVE WHEN A CASE IS ADMINISTRATIVELY CLOSED

The South Pasadena Police Department's goal is to investigate crimes thoroughly and with due diligence in order to prepare cases for appropriate clearance or submission to the LA County District Attorney's office for prosecution. Research and experience has shown that not all cases are solvable. The decision to assign a case to a Detective for follow-up investigation is dependent on the specific facts of your case. Studies have shown that the presence of these facts, commonly referred to as "Solvability Factors," can predict whether a detailed follow-up investigation is likely to result in the arrest and prosecution of the suspect(s) or the recovery of property, in a manner that is cost effective to you, the taxpayer.

The greater the number of "Solvability Factors" present, the higher the likelihood your case will be solved. Some of the key elements we look for are:

- The suspect is named
- · High-quality video/images
- The victim desires prosecution
- Victim/witness(es) can identify the suspect(s)
- There is a distinctive description of the suspect(s)
- The suspect's license plate is known
- Significant physical evidence has been located

The Detective Bureau has reviewed your report and related circumstances. At this time, we have exhausted all leads and there is no other workable information to assist us in identifying who committed this crime or any other factors to assist us in the return of your personal property. As a result, the investigation of this case has been closed. If you discover new information which may help us further investigate your case, please call 626-403-7280 or go to the front desk of the Police Department.



#### Recommendation

It is recommended that the Public Safety Commission receive and file a report on South Pasadena's (City) efforts to address homelessness in South Pasadena.

#### **Executive Summary**

The City of South Pasadena continues to make progress in identifying and assisting its unhoused population, utilizing homeless and housing-related resources, and partnering with government and non-profit groups to develop and implement a coordinated, regional approach. On January 23, 2024, the City participated in the Los Angeles Homeless Services Authority's (LAHSA) 2024 Point-in-Time count to estimate South Pasadena's unhoused population. During the count, 15 individuals were counted, three of whom were in vehicles. No other improvised dwellings (encampments, tents, or makeshift shelters) were counted.

In the 2023 Point-in-Time count, 14 individuals and 11 improvised dwellings were counted. The City's count was then submitted to LAHSA, which applies a multiplier based on Service Planning Area surveys to each improvised dwelling type counted to estimate the total number of unsheltered persons experiencing homelessness in South Pasadena. LAHSA's estimated 2023 homeless count in South Pasadena was 31 persons, down from its 2022 estimate of 50 persons. LAHSA's 2024 estimate will be released later this year.

City staff works closely with external groups such as the San Gabriel Valley Council of Government (SGVCOG), Los Angeles Center for Alcohol and Drug Abuse (L.A. CADA), West San Gabriel Valley Mental Health Evaluation Team, Los Angeles County Department of Mental Health, Los Angeles County Department of Health Services, South Pasadena Chamber of Commerce, local individuals, and local grassroots organizations. The Police Department has increased patrol and outreach in specific areas such as the City's business district, the library, City parks, and the MTA's L-Line (Gold Line) platform. City staff continues to pursue grant opportunities and utilize existing grant funds effectively. Below is a summary of the City's various support efforts for those experiencing homelessness.

#### Discussion/Analysis

Over the past several years, the unhoused population has steadily increased in South Pasadena and throughout Los Angeles County. However, in 2022 and 2023, the unhoused population has stayed about the same. However, LAHSA's estimates derived from annual Point-in-Time counts do not reflect the transient daytime unhoused population, who use City services while passing through town and obtaining meals, clothing, or other items from local resources. The City leads or participates in various programs that serve people experiencing homelessness in South Pasadena.

#### Supplemental Services Program

The City participates in the Measure H-funded Services to Supplement Existing Services Program (Supplemental Services Program) administered by the SGVCOG. This program entails general, proactive outreach to people experiencing or at risk of homelessness by a multi-disciplinary team staffed by the L.A. CADA. On Mondays from 9:00 a.m. to 3:30 p.m., the team provides the following services: street outreach, housing navigation, mental health support, case management, and homelessness prevention and problem-solving. From July through December 2023, L.A. CADA's Supplemental Services team accomplished the following in South Pasadena:

- 69 contacts (including first-time encounters and follow-ups)
- 124 services provided
- 7 referrals/linkages to food pantries and interim housing

#### San Gabriel Valley Crisis Assistance Response & Engagement Team (SGV CARE):

The City also participates in SGV CARE, a multi-city regional mobile crisis response program administered by the SGVCOG. Specifically, SGV CARE entails the response of a two-member mobile crisis team to non-violent 9-1-1 calls from residents experiencing mental or behavioral health emergencies. The SGV CARE team is staffed by L.A. CADA and consists of a licensed behavioral health clinician and an EMT/peer support specialist. In addition to crisis deescalation, the team makes referrals to local area resources, which includes coordination with medical, mental health, and behavioral health services and, for residents experiencing homelessness or at risk of homelessness, to homeless services providers. As of December 2023, the SGV CARE team responded to 62 clients in South Pasadena, not including follow-ups.

As of February 2024, 49% of SGV CARE's clients are unhoused, 37% are housed, and 14% have an unknown housing status. Since its launch as a pilot program in August 2022, SGV CARE has operated a mobile crisis team serving the cities of South Pasadena, Arcadia, and San Marino. The team's hours of operation in South Pasadena, Arcadia, and San Marino are Mondays, Wednesdays, Thursdays, and Fridays from 8:00 a.m. to 6:30 p.m.

#### South Pasadena Police Department Homeless Outreach Team (H.O.P.E.):

The South Pasadena Police Department's Homeless Outreach Program (H.O.P.E.) was created in 2016. The goal of the H.O.P.E. program is to assist the City's unhoused population in "breaking the cycle" of homelessness. The Police Department works closely with several service providers to help accomplish this goal by connecting the unhoused with various resources that address housing, mental health, medical, and legal assistance. Some of the service providers the

Department works with include The Los Angeles County Mental Health Department, Los Angeles County Department of Health Services, Pasadena Union Station, Los Angeles Homeless Authority, Los Angeles, and several local organizations. Most of the unhoused have built trust with the officers as they know they are not removing them from the City but instead trying to assist where they can.

#### <u>Homeless Outreach Service Team (H.O.S.T.):</u>

In October 2018, the Police Department began working with the San Gabriel Valley Homeless Outreach Services Team (HOST). HOST is comprised of multiple police agencies throughout the San Gabriel Valley, extending from South Pasadena to Pomona. This team of officers consistently visits the participating cities to interact with the unhoused and provide needed resources. HOST is funded through the Los Angeles County Measure H funds and focuses primarily on outreach efforts.

#### Mental Health Evaluation Team (WSGV MET):

In an effort to address the increase of homeless with mental health issues, the City joined efforts with the Arcadia and the Monrovia Police Departments, in addition to the Los Angeles County Department of Mental Health, creating a specialized response team. This team, the West San Gabriel Valley Mental Evaluation Team (WSGV MET) provides resources and finds long-term assistance for those suffering from mental health issues. WSGV MET provides mental health intervention services 50 hours a week in the three cities it serves (Monday through Saturday). A Los Angeles County Department of Mental Health Clinician is often paired up with a police officer from one of the participating agencies. The mental health clinician is on patrol with the officers an average of four shifts per month in each city.

#### **Community Partnerships:**

The Police Department works diligently with community members, non-profits, and faith-based groups to assist the unhoused. The groups provide blankets, food, clothing, and personal hygiene packages, which are given to the police officers to hand out as they come in contact with the unhoused. Faith-based organizations have provided free sack lunches to the unhoused for several years, Monday through Friday. In addition, faith-based organizations have donated clothing, care packages, and other items of necessity, which they hand out to those in need. To gain the trust of the unhoused, police officers often take the time to talk with them to understand their needs and concerns.

City staff has donated their time by serving warm meals to the unhoused who attend meal giveaways.

#### LA-Hop:

The Los Angeles Homeless Outreach Portal LA-Hop.org was introduced to City employees through email. LA-Hop.org is an online portal that reports people experiencing homelessness in Los Angeles County. Once reported, an outreach worker will attempt to contact the subject experiencing homelessness. Outreach teams start by building a trusting relationship with people living on the streets and determining their needs. Outreach efforts can be as simple as helping someone experiencing homelessness get an identification card or as complex as assisting an

individual meet medical and mental health needs. The ultimate goal of outreach services is to help those who are homeless find a permanent home. LA-Hop.org is funded through Measure H funds and concentrates on outreach.

While there is much work to be done, the City is achieving great results in its efforts to assist those experiencing homelessness in South Pasadena.
