This morning's FB feed has two posts from two different people that address a similar theme from two different perspectives. The first is a drawing of a woman. The <u>prosetry that accompanies it</u> speaks of how a person is seen from another's point of view contrasted with who they feel they are and what they project.

Ironically, the post that immediately follows the one of the drawing speaks of the <u>attributes and impacts</u> of positive people.

In policing work, as well as working with the public, there is the actual person who presents their self to the public. But the trappings of myths, misunderstandings and misinterpretations, fear, and lack of information, cause many unfortunate results.

I'm glad I didn't choose law enforcement as a career path. It appears my level of naivete could lead to the death of me. At least my expectation of the best of any person who I meet will give me the opportunity to show respect to another, be an example of honoring their humanity, and open the door to possible rewarding experiences because of having met them.

Did you know that Ed Begley, Jr. suffers from Parkinson's disease? It's a non-visible disability with subtle hints about its existence that only trained specialists recognize. Imagine his (or any other person with a non-visible disability) trying to put another (especially a law enforcement officer) on notice about his condition as the officer begins doing things that will exacerbate the condition.

### April 2022


As a result of direction from the City Council, Staff returned to the City Council, which resulted in the
consolidation of 3 Commissions, the dissolving of 2 Ad Hoc Committees, reducing meeting frequency of
2 Commissions, and increased commitment to training and recognition efforts.

### May 2024

 At the request of the City Council, staff returned with a revisit analysis on this item focused on hours and costs. Following the City Council discussion at the May 1, 2024 City Council meeting, staff was directed to solicit further input from the Commissions on opportunities for consolidation and efficiencies.
