Dear Councilmember Cacciotti,

I write to express my profound concern about safety at the intersection of Garfield Avenue at Clark Place in your district in northeastern South Pasadena.

In January 2009, my parents purchased a property near this intersection. At the time, I was in first grade at Marengo Elementary. In the fifteen, going on sixteen, years since then, my family and I have repeatedly noted the dangerous nature of the Garfield/Clark intersection. Consistently, many vehicles fail to make a complete stop — or even stop at all — at the stop sign there. While already concerning during the day, it is doubly so after dark. We have experienced multiple close calls, and often the driver does not even seem to notice that there were pedestrians in the crosswalk.

I suspect this issue is particularly acute because a large volume of vehicles passing through this intersection are going to or coming from the 110, and their driving more strongly reflects what is acceptable on a high-speed, grade-separated right-of-way like the 110, rather than what is, fundamentally, a residential street.

I implore the Council and any relevant City committees and departments to address the safety concerns that the Garfield/Clark intersection consistently present. I ask that the City strongly consider implementing aggressive traffic calming measures at this intersection, including, but not limited to:

- flashing red beacons or reflective post decals for the stop signs, like what has been implemented at the intersection of Garfield and Monterey;
- flexible bollards that narrow the travel lanes, similar to the ones trialed along Oak Avenue near Marengo Elementary;
- pedestrian crossing signs and beacons; and
- increased traffic enforcement.


