WHAT IS ACTIVE TRANSPORTATION?

Active transportation is human-powered mobility, such as biking or walking.

WHY IS IT IMPORTANT?

Walking and biking to school provides a whole host of advantages for children and the community, from reducing congestion and air pollution around schools, to improved mental and physical health for children, improved test scores, sleep, attentiveness, independence, resource fulness, resilience and social skills.



50 years ago, half of all children walked or cycled to school. Today it is only 11% and declining.

WHY MARENGO?

Marengo is uniquely situated where a majority of its student population lives within one mile of campus, a distance very suitable for elementary-aged children to walk and bike.

Walking and bicycling are good for children, yet surveys show that active transportation has become less prevalent. With this decline, students of this generation are missing the opportunity to explore the world through diverse means and build up those needed skill sets.

We should be encouraging more daily physical activity for our children. Walking to school is one of the simplest, most effective, and most affordable strategies for kids AND adults to build physical activity into their lives. One mile of walking translates to 2/3rds of the recommended physical activity each day.

We can promote this behavior shift through a series of small initiatives designed to make active transportation fun.

PROGRAMS

BIKE BUS / CLINICS

Every Tuesday morning, parents lead a safety-in-numbers bike ride to school from the North and South of Marengo. Participants can ride from the beginning of the route or join at any point along the way.

Marengo Elementary will also host a series of bike clinics designed to provide a safe environment for children to learn how to ride a bicycle.

WALK TO SCHOOL

- Ring was created in 2012 and was one of the first video doorbells.
- Their products now expands to interior, exterior cameras, pet tags and alarm systems.
- In 2017, Ring launched Neighbors App.





- Ring's philosophy has three rings of security:
 - Front door
 - Outside the home
 - Around the community (Neighbors App)













- Ring product NOT required to join app.
- Can be viewed on cell phone app or computers.
- Designed as "Virtual Neighborhood Watch" during pandemic.
- Different from other apps (e.g. Nextdoor)
 - Moderated by Ring.
 - Delete post if not related to crime or missing pets.
 - Cannot solicit.








- Users can share videos and photos from Nest, Arlo, smart phone videos, etc.
- Each post will be anonymous. Each post is tagged with a sequential number, "Neighbor 1, 2, 3, etc." Each time log in, will be assigned a new number.
- Privacy is important so all posts are anonymous and exact locations on maps are not shown.














- "Request for Assistance" post
 - Allowed LE agencies to request for assistance by asking residents to send/post videos of investigations.
 - LE agencies could only request from within own city.
 - Could geofence specific area.
 - Discontinued as of January 2024.
 - LE agencies can still make post, but not request.
