Ending totals for August 2024 for the Checking Account reflected \$2,990.88, the Checking 501c3 reflected \$82,623.57, and Savings 501c3 reflected \$140,081.10. She reminded the Commission to turn in all receipts to ensure the highest return in taxes.

- 7. <u>DESIGN CHAIR REPORT</u>: Event & Site/Design Chair Jontz reported on a discrepancy in the title of the float. He is currently working on getting it fixed prior to printing the program for the event.
- 8. <u>CONSTRUCTION CHAIR REPORT</u>: Construction Chair Fillingham the great crew working on sculpting on Sundays only. The three major animals should be completed by the end of the month. When the animals are close to completion, they will bring in more volunteers to learn how to sculpt.
- <u>DECORATION CHAIR REPORT</u>: Decoration Chair Benjamin reminded the group of the workday this Saturday, September 7, 2024 and will be completing an inventory on September 4, 2024. She also reminded the group to provide any updates they would like to go out in the email blast.
