South Pasadena needs to ensure that it is the progressive and inclusive city it claims to be. In order to do so, major police reforms need to be made. Officers should be given de-escalation training and less training regarding the use of lethal violence. Not all officers need to carry a gun - especially in SP - it is threatening and does more harm than good in our community. SPPD should act as community builders, instead of trying to catch citizens doing something wrong. Sure, if someone is being dangerous, actions need to be taken to ensure the safety of others. But, in many cases, punishment is not the best solution. Officers should be willing to have a reasonable and open conversation with citizens instead of only looking to punish them. We want to regard our PD as contributing to the SP community instead of creating unnecessary fear.

I think officers need to be better immersed in the community programs in South Pasadena so that they can learn about and become a welcome part of the community and so residents feel comfortable communicating with their law enforcement. This will increase safety and a sense of community. Additionally, within the PD, there needs to be individuals who have received education for ethnic studies, so that POC are better understood and treated, and for psychological studies, so officers understand how to handle situations without force and instead with communication.

SP should lead small cities across America in the rebuilding of law enforcement.

Dear City Council,

My name is Libby Rainey and I was born and raised in South Pasadena and live here now. In this pivotal moment of social upheaval and mass protest in defense of Black lives, South Pasadena has a historic opportunity to not just gesture at police reform but instead enact real, substantial change to make our community safer and to acknowledge the racist and inherently violent role police play in our society broadly and neighborhoods locally. The city of Minneapolis just made history pledging to dismantle its police force. I am calling on you, our city council to do the same. Together as a community, we can build a model of safety that prevents harm and focuses on life-affirming services like education, housing and mental health while divesting from oppressive policing, which is rooted in anti-Black violence and dates back to the slave trade. Abolition is not a pie-in-the-sky idea, but rather a practice and comprehensive ideology developed by Black women and pushed into the mainstream by community organizers. We should study it and take it seriously as a pathway to true accountability. If we take the lead of abolitionist organizers, we can be one of the first communities in the country to take this historic step. Another world is possible and that starts right here in our backyard. Please hold an open town hall where we can discuss this with all our neighbors at the table, and please listen to the Black and Brown youth of South Pasadena, who deserve better.



This is my public comment for the 6/10 closed session on labor negotiations which I understand is happening tomorrow, Wednesday June 10th:

I am a South Pasadena resident writing in support of South Pasadena Youth for Police Reform's requests for city council. I support their request to freeze SPPD's budget until meaningful changes are made toward creating a racially equitable and community-driven police department. This includes changes to training and recruiting, reforming internal SPPD policies, increasing transparency of SPPD practices, and changing city ordinances. I especially want to voice my support for increasing officers' training in de-escalation tactics and mental health, and having mental health practitioners lead wellness checks. Additionally, I believe a higher proportion of the city budget needs to go towards preventive social services and less towards policing. Strong social service programs should be prioritized because of their role in helping South Pasadena residents stay healthy and safe.

hello. i live down the street on mound avenue. a few years ago, i suffered a mental health crisis and was feeling suicidal, at which point my parents called the police and they came to our home. unfortunately, the actions that sppd took on that day compounded the problem. i'd already had a number of negative encounters with police by that point, so i had requested to interact with other first responders, who were also on site. instead, officers insisted that was not a possibility, then chased me through my house and tackled me on my niece's bed. one officer was later quoted in the local newspaper as looking out for my well being, hoping i get the help i need. i honestly feel like you didn't listen to me then, when i was willing to be cooperative, and you probably won't listen to me now, but nothing you did that day was helpful. thankfully things did not turn out for me the way they did for vanessa marquez. i can get over what happened and i hold no grudge, but vanessa deserved better. our neighbors deserve better. sending armed officers into situations where people are in a state of deep despair is the wrong way to address their suffering. things are broken in their current state. this is why i endorse the proposals put forward by south pasadena youth for police reform and believe the police budget should be frozen until these very necessary changes are implemented. thank you.

It is clear that the COVID-19 pandemic has and will create revenue shortfalls for the City of South Pasadena, as well as the State. General Public Comment

Dear City Council,

I wish to express my grave concern over what we understand to be a proposal by the City Manager and Finance Director to turn over our City's community services department, including parks and recreation, to an outside organization, apparently as part of an effort to cut costs. This potential loss of local control over the City's fields would be devastating, to the community, local sports leagues, and other organizations such as the scouts. AYSO and SPLL have invested hundreds of thousands of dollars in our City's park facilities and developed strong relationships with the City, so that our kids can participate and enjoy all the benefits of participating in organized sports. Turning this over to a group from outside the City and/or our local community, could jeopardize all of that. We are concerned that these contractors could be granted substantial, if not exclusive, control and authority over our parks and other facilities, depriving community-based organizations from access to these facilities. Additionally As we have experienced with others to whom certain city functions have been delegated, any short-term cost savings may be overshadowed by long-term increased costs and lack of control.

Further, Community Services should be able pay for itself. It should never be allowed to be minimized or farmed out to others, especially in a city like ours which is small and with many young families who rely so heavily on the services and facilities offered and managed by this department. Apparently, a few decades ago, there was a similar plan by City staff. The community fought back and was able to keep recreation within the City, where it became a vital department.

I am concerned about turning this important component of the City to an outside group or agency and urge the City Council to direct staff to drop this proposal. It would be an extreme loss to South Pasadena to lose such vital events such as concert in the park, movie in the park, egg hunt, etc. Further, to increase costs to SPLL, AYSO, scouts, and familes wishing to use the gazebos would be such a detriment to the residents.

Please consider the many pleas you are receiving to keep Community Services here in South Pasadena.

Please Read Aloud

On June 7, 2020, the City Council held a closed session meeting that was agendized as, "CONFERENCE WITH LEGAL COUNSEL— Anticipated Litigation, Pursuant to Government Code Section 54956.9(d)

(2)." I have no idea what the subject of that meeting was, but it appears that this description violates the Brown Act. A League of California Cities handbook on the Brown Act states that in the instance of

threatened or anticipated litigation the Council generally needs to identify the facts and circumstances giving rise to the anticipated litigation. In the recent case of *Fowler v. City of Lafayette*, the Court of Appeals

found that when litigation has been threatened, it may be discussed in closed session only if a record of the threat is made before the meeting that is available for public inspection pursuant to section 54957.5.

The court found a violation where the City merely identified the threat in the project file, rather than in the agenda packet made available before the meeting. Nor is § 54956.9 to be used as a subterfuge to

discuss non-litigation oriented policy decisions. A previous City Council was warned by the District Attorney's Public Integrity Division not to mis-agendize closed sessions to hide the subject matter. Each

Council member should make sure that the public is sufficiently informed about the subjects of closed session meetings so there is no need to speculate about what those subjects might be. From now on, the

city needs to adhere to Fowler in making closed session agendas.

Dear Mayor and City Council Members,

The WISPPA board would like to share some concerns regarding city council and commission meetings. While we understand that Covid-19 has forced the city to make a number of changes as to how meetings are held, we feel the public is not being heard in the new format, We appreciate the city changing the number of words for comments to 250, although even that is not enough. The deadline for comments is still the day before the meeting which far from ideal. Often in the past, the public would like to make a comment as the meeting progresses. If you must hold to this deadline, we suggest that the comments submitted the day before be addressed in the meeting. The new format prevents any spontaneity and the whole process feels very one way.

The meetings need to be shorter with key, contentious issues at the beginning of the meeting. City council comments should be at the end.

We have some suggestions we hope you might consider. Hold city council and commission meetings on a platform such as zoom while we are social distancing. Hopefully in the near future we will be able to hold meetings live with social distancing taking place by perhaps having a screen set up (in the courtyard or elsewhere) and then allowing just a few people at a time inside the chamber.

The city needs to improve notification of meetings. Commission meetings are not always posted in an obvious place on the city website. Some meetings are listed on the home page, others not. The city calendar has disappeared which is unfortunate because it was very helpful in looking at what meetings were coming up.

We would like to see the public being able to ask questions at commission meetings as things are discussed. Commissioners are the public's representatives and should be able to have discussions with the public.

It is vital that the City and City Council make sure that the public voices are heard regardless of whether is it criticism or praise. Please remember that for each person that complains about an issue, there are many more who agree but are silent.

Hello Council Members, Mayor, and City Manager,

We are South Pasadena Youth for Police Reform, and we are a group of current and former SPHS students asking for meaningful change in our community. In 2016, this council passed a resolution declaring "it the public policy of the City to be inclusive and to respect the inherent worth of every person."

If this national moment has taught us anything, it's how the deeply broken policing system has let down our Black community members and other marginalized populations. We are now asking that our elected officials and public servants fulfill the promise of the creed of this city and put action to words.

We want to begin by saying we don't want to abolish the police. In fact, we appreciate our department here in South Pasadena and the work they do to serve the community. Our officers are good-hearted people. From fourth of July parades to graduations, they have been there for us. It is the system under which they operate that is failing us, however.

We are asking that the South Pasadena City Council seriously reconsider the current draft budget, including increases to the exorbitant police department budget, until our list of proposals are met. Tonight, we are firmly asking the city to commit to just three fundamental changes in order to show our leaders are willing to represent the will of the people:

1) First, we are asking that we update the police department's policy manual to meet the changes recommended in the 8 Can't Wait reforms many departments across the country are making. We have already decided to drop the use of neck holds. We are asking that the other seven changes be made, in order to make sure that every possible alternative is exhausted before an officer uses their gun. 2) Second, we are asking that the police department begin to take the call for transparency much more seriously. The last annual report from 2018 was only recently made public a few days ago. We ask that the city manager and police chief respond to our public records request, seeking instances of misconduct, civilian complaints, and the current labor contract including any MOUs. We hope to increase transparency greatly in our department, so that in the future we have data regarding where enforcement efforts are located, how much is actually within the city, and what methods are being used.

3) Third for today, we are asking that our council commit to a charter amendment to create a civilian oversight mechanism within the public safety commission. Currently, the commission has very little actual capabilities and is constrained under the city manager. Already, cities across the country and committing to this change, including Pasadena.

We hope that we can continue the progress already made by our leaders and commit to reforms that stand on the right side of history.

My public comment:

Lorne Platt and I started South Pasadena Little League's Challenger program 10 years ago. This division is Little League International's adaptive baseball program for individuals with physical and intellectual challenges. It gives boys and girls ages 4-18 the chance to play baseball and wear the same uniforms and safety equipment as other Little League players.

We started with 1 player our first season but have grown to over 30 registered athletes. We also started playing Challenger teams from other districts, allowing the players to make new friends and play with those with similar challenges.

SPLL does not charge a registration fee for this division, but is still able to provide the players with uniforms, equipment, and a photo packet. Having no fee is very beneficial to these families as many incur high medical bills due to their children's mental and physical challenges. Also, many of these athletes need wheelchairs to get around, so the cost of transportation can be high too.

I understand there is a city proposal to outsource the city's community services department, including parks and recreation. I strongly oppose this proposal unless SPLL is not charged to use the fields at Orange Grove and Arroyo parks. Having to pay for field use would at least necessitate charging the Challenger families a fee they might not be able to afford, and at most could shutter the entire SPLL softball, baseball, and Challenger programs. Please don't let this happen!

The MTIC can provide alternative ideas and solutions already in use in other cities which are less costly and more effective and aesthetically pleasing than those described in the report, such as staff's recommended concrete barriers costing \$10,000 per month per block.

Let's not move forward blindly but instead use the resources available, including the free knowledge and experience of the MTIC, to develop recommendations which can be more cheaply, easily and expeditiously implemented while ensuring that we do not create traffic safety issues or unintended consequences such as diversion onto local residential streets. As I have previously suggested, the City should also be exploring the swift implementation of measures to slow our streets, like Pasadena, as a complement to business district specific treatments. Our neighborhoods need our help too.

2. Here are my entire comments, for the City Council's review and the record:

Honorable Mayor Joe and Members of the City Council,

I have reviewed the presentation prepared by staff and posted to the City website the same day this meeting was originally scheduled (June 3rd). I am excited to see the City considering creative options for supporting our local dining establishments who have suffered as a result of the COVID-19 pandemic and related restrictions and am in favor of this proposal conceptually, but it should be implemented responsibly. In particular, I am concerned that the second phase of the proposed pilot program involves use of the public right of way, including the parking lane and potential travel lanes, however, the only citizen or public input sought is through a "Business District Survey." While it is unclear who exactly was invited to participate, what is clear is that this matter has not been brought to the City's new Mobility and Transportation Infrastructure Commission, and, according to the staff presentation, there is currently no plan to do so, as the MTIC is not even referenced in the list of "Next Steps" on page 11.

While I see no material impediment to moving expeditiously to implement curbside pick-up and the use of off-street private parking lots for "al fresco dining," before the City Council considers any plan that includes the possibility of using the public right of way, either a parking lane in front of a business or closing a side street, it should FIRST be submitted to the MTIC for review and recommendations. This proposal directly impacts mobility and use of City streets. Without a doubt, the MTIC could provide additional ideas and solutions which could be less costly and more effective (and aesthetically pleasing) than those briefly described in the report, such as the recommended concrete barriers costing \$10,000 per month for one block. Other methods are available and being used by other cities to support their local restaurants. Let's not move forward blindly but instead use the resources available, which in this case is the knowledge and experience of the MTIC (which does not cost the City a dime), to develop recommendations which can be more easily, expeditiously, and cheaply implemented while at the same time ensuring that we do not create traffic safety issues or unintended consequences, such as diversion of traffic onto local neighborhood streets. As I previously suggested and was discussed during Commissioner comments at our last MTIC meeting, the City should also be exploring the swift implementation of measures to slow our streets, as the City of Pasadena at least a month ago, as a complement to business district specific treatments. This comment is to clarify that the draft budget in the agenda packet posted on May 29th is different from the draft presented to the Finance Commission on May 26th.

Among other changes, more than \$4.6 million was added to special funds 104, 215, 233, 236, and 327.

To understand the increase, which was not explained in the agenda report, an updated revenue detail and expenditure summary by fund were requested. The increase, however, cannot be explained by actual revenues and expenditures for the current fiscal year as those are reported in the revenue detail and expenditure summary.

Also, it appeared that in the prior draft budget (and in prior adopted budgets), special fund balances were calculated using budgeted revenues and expenditures, not actual revenues and expenditures. (The attached spreadsheet tracks the balances of the five funds mentioned above as reported in recent financial documents.)

The expenditure summary further indicated that the balance of special fund 500 was calculated using a budgeted expenditure that exceeded this year's adopted budget by more than \$3.6 million.

Inquiries have been made, as well as a request to update the link to the draft budget on the Finance Department's website so as to avoid confusion between the two drafts.

A critique of the City's financial reporting has since been circulated by a former Finance Director. The above observations were made independently of, and prior to, the unsolicited receipt of that report. Thank you for your consideration of the above.

For Item 17.Presentation of Draft Budget for Review Prior to Adoption on June 17 The SPPD's proposed budget for FY20-21 is 4.6% higher than the current year, despite a \$3.5-4M revenue shortfall. We have a full time officer that works as an advocate with our local homeless population o get them food, medical services and even housing. And the School Resource Officer who develops a relationship with troubled kids to be sure they get the help they need or to be sure they are no a danger to anyone else. For FY20-21, transfer \$1 million from PD to hire mental health and/or social work professionals to begin investing in a community-led public safety programs. Doing so will also save funds since mental health and social workers are paid less than what police are paid. Since violent crime has steadily been decreasing across LA County since 2014, except in the area of violent crime against women by intimate partners (which has risen by ~25% in the same timeframe), and is substantiated by SPPD's report of a 19% reduction in crime, with no substantial protests in South Pasadena during recent weeks, we can afford to invest in alternative models of community-led public safety. Begin so, by cutting \$1 million from PD to hire appropriate mental health professionals and social workers to handle these areas of public safety previously done by our armed law enforcement.
