In reviewing the police reports for the July 8 and July 10 incidents, there are blatant inaccuracies. We need to remedy this ASAP.

Did 911 calls come in on July 8th and/orJuly 10th? If so, did dispatch record information from the callers?

Has a detective been assigned to our cases? As of 7/14, no one from SPPD has contacted us. When will we hear from the detectives? Why aren't the 7/8 and 7/10 cases connected? Why was Joe Richcreek arrested only for throwing a rock and not for spitting on me during a deadly pandemic?

It's my understanding that Joe Richcreek has prior offenses. Why was he released?

He returned to the scene of his first attack and assaulted Fahren James. Fahren James and I need protective orders.

The assault occurred almost a week ago. No one from SPPD has reached out to me. I was fortunate that a testing site in Pasadena took pity on me and gave me a Covid test this morning.

I've been a resident of this community for over twenty-five years. While you are working on a FY 20/21 budget for public safety, we are still waiting for any communication from our police. We deserve (and must receive) services and protections from SPPD.

Mayor Joe and Councilmembers,

Along with staff and a City consultant, two citizen commissions developed projects designed to, at long last, start chipping away at the impacts of cut-through traffic in our community. These projects were approved by this Council and, in December 2018, adopted by the Arroyo Verdugo Communities Joint Powers Authority (AVCJPA) for implementation with Measure M funds. Over a year later, current staff, unilaterally and without any notice to, or input or involvement by, any member of any commission or this body, elected to drop all but one of the projects and replace them with three wasteful projects which no one outside staff ever requested, considered or approved.

Not only did this action lack transparency, it violated Metro's Measure M Guidelines which require, among other things, public participation in all projects submitted for approval. Here, there was NONE. When the MTIC learned of these changes at our last meeting, we were shocked and outraged. Multiple times, I asked staff how our concerns could be addressed. I was met with either silence or the unapologetic message that it was a done deal and too late. Not a word since. What we were NOT told is that, the following week, these changes would be considered by the AVCPA. South Pas was the ONLY city proposing new projects without citizen support or Council approval. We have a chance at the AVCJPA meeting on 8/6 to right this wrong, but we need Council action before that. Please help.

Apparently we hear someone has objected to the emblem and the flag patch is being considered for removal.

While I know some people do not believe the flag should be protected by the police (that thin blue line). I personally oppose removing a patch that has been around for some time in support for our South Pasadena Police officers. We have always been treated with respect by our officers in every contact since the late 1960's.

If the "Thin Blue Line" is removed today, then will the "Thin Red Line" for firefighters be next? Already some idiots in Washingtonville, NY cut down the flagpole this month and desecrated the memorial for FDNY firefighters killed on 9-11-2001 in the World Trade Center attack.

Dear Mayor and City Council Members:

Please direct staff to place the renewal of the Utility Users' Tax only on the November ballot. Being the third source of revenue for the City, it is vital that this funding mechanism be renewed.

Please do not support a ballot measure involving the increase of the building height limits. This controversial issue should be discussed within the context of the general plan/specific plan updates process, form-based development code, and the housing element process. We must re-consider the physical needs and growth of the City within, hopefully soon, a post-COVID pandemic world. Business, retail, and commercial spaces contained within tall buildings may no longer be relevant as more people work from home and order essentials through the internet. Affordable housing may also change and not be anchored to mixed use developments. A ballot measure at this stage of the City's planning efforts is premature and counterproductive.

Lastly, please do not support a ballot measure for transient occupancy tax for short-term rentals. In reviewing an Airbnb online map, only 15 short-term rentals are being advertised within the city's limits. This is not a moneymaking operation that the City should waste its time on. And, except for the historic Raymond Hill Hotel that was demolished in 1934, has there ever been a need for a moderately-sized hotel in South Pasadena since that time?

The November 3rd ballot measure should focus on the UUT and not muddy the waters with other measures that could possibly result in the UUT not passing.


I have reviewed the staff report related to the 3 ballot measures proposed for the November ballot: 1) Continuation of the current UUT, 2) Repeal of the current voter initiative from 1983 to restrict commercial building heights to 45' and #3 a bed tax.

I am in favor of #1, the UUT being placed on the ballot, and very much opposed to #2 and #3, in particular repeal of the 45' height limit.

In 1983 if it hadn't been for the fearless opposition to 2 high rise office buildings, one 10 story and one 12 story, across Fair Oaks from Bristol Farms down to MacDonalds by the Save South Pasadena Committee and a voter initiative put on the ballot that won, we would have unrelenting traffic and a major eye soar at our gateway entrance at the 110.

The citizens of South Pasadena do not want to fight that battle again to save our town from over development. It's a loser and will be highly unpopular to repeal the 45' height limit, just check the chatter on social media the last few weeks!

The UUT is a necessity to continue city services that the community has come to depend upon. Dear Mayor and City Council Members:

These are strange times with the pandemic and economic uncertainty. Yet even before Covid-19, there was a growing concern about the lack of transparency at city hall.

Most recently, a "confidential" audit conducted two years ago magically appeared, prior to a lawsuit where if would have been exposed. And the lawsuits and legal costs keep mounting.

A lot of people are wondering, "What's going on over at city hall, and what's my council member doing to protect my town?"

Let's face it, the city needs the Utility Users' Tax (UTT) to pass in November. as it is a vital source of revenue. Yet a growing number of residents do not trust the agendas of some council members and our city manager. Why would we vote yes for the UTT when it's clear that the city is trying to lift building heights at the same time for developers?

That's why I urge you NOT to support a ballot measure that involves increasing building heights. This is an incredibly controversial issue that should be discussed in the context of the city's general plan. We need to address affordable housing units first and not the luxury units the planning department has rubber stamped. I love South Pasadena. I do not want to live in downtown Glendale.

In regards to the transit occupancy tax for short-term rentals, this is being proposed without actual data. At one city council meeting Marina Khubesrian said when she googled Airbnb in South Pasadena "Thousands of places came up and I know at least 50 of them are in South Pasadena." Had she spent another five minutes to look at the map showing where these rentals are located, she would have seen that at that time there were only 15 in the city.

And, the TOT only applies to stays less than 30 days. I know a number of people in my neighborhood who have opened their homes to researchers from the Huntington Library,

doctors doing residencies at Keck, and students doing internships at CalTech and JPL. A "bed tax" would not apply to any of these stays. And the responsibility for collecting such a tax would fall on the city. This is essentially a zero-sum proposal.

Please keep the focus of the November 3rd ballot on the UUT, so it has the highest chance of passing. There is just too much at risk.

I urge the city not to shirk the state requirement to zone for more housing, particularly affordable housing. The reality in the Los Angeles metropolitan area is that more affordable housing is needed and more of it should be located along transit lines and in close proximity to shopping and other services.
