This Resolution contains changes to the language in Section 1 and Section 2 and the addition of the second paragraph to specify how the City plans to participate in CalRecycle's Beverage Container Recycling Payment Program.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH PASADENA, CALIFORNIA, AUTHORIZING SUBMITTAL OF AN APPLICATION TO PARTICIPATE IN THE BEVERAGE CONTAINER RECYCLING PAYMENT PROGRAM (FISCAL YEAR 2019-20) AND RELATED AUTHORIZATIONS

WHEREAS, pursuant to Public Resources Code section -48000 et seq. and section 14581(a)(3)(A) of the California Beverage Container Recycling and Litter Reduction Act, the Department of Resources Recycling and Recovery (CalRecycle) has established various payment-grant programs -to make paymentsprovide funding to qualifying jurisdictions for certain programs; and

WHEREAS, the City of South Pasadena desires to submit an application for participation in CalRecycle's Beverage Container Recycling Payment Program to fund installation of water refill stations within centrally located public facilities within the City; and

WHEREAS, CalRecycle's procedures for administering payment programs require, among other things, an applicant's governing body to declare by resolution the necessary authorizations related to the administration of the payment program.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH PASADENA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The City of South Pasadena City Council is authorized to submit an application to CalRecycle for participation in CalRecycle's Beverage Container Recycling Payment Program for the purpose stated above any and all payment programs offered.

SECTION 2. The City Manager, or his/her designee, is hereby authorized as Signature Authority to execute all documents necessary to implement and secure payment for participation in said Program.

SECTION 3. This authorization is effective until rescinded by the Signature Authority or this governing body.

SECTION 4. The City Clerk of the City of South Pasadena shall certify to the passage and adoption of this resolution and its approval by the City Council and shall cause the same to be listed in the records of the City.
