HOSPITALIZATION RATES

- Total Cases Requiring Hospitalization ~ 6283 13%
 Currently Hospitalized ~ 1477
- Hospitalizations Requiring ICU ~ 27%
- Hospitalizations Requiring Ventilator ~ 19%
- Slight Decrease in Hospitalizations ~ 54 fewer patients



AVAILABLE HOSPITAL BEDS

- 70 designated 9-1-1 receiving hospitals in LA County
- Daily available bed capacity based on staffed/unoccupied beds
- Total Available: 1,914 (Adult, Pediatric and ICU)
- Total surge capacity approximately 12,000 beds
Surge Facilities include:
 - Hospitals ~ Convention Centers ~ Fairgrounds ~
Mercy Ship



Local Businesses

- City staff continues to support local businesses
- ACE Hardware ~
 - ~ CDC and County Guidelines are being followed
 - ~ County protocols identify total occupancy load of 75
 - ~ Management reports only 25 customers at a time
- No other significant issues to report



TESTING

- Current testing capacity is 90 - 100 K tests a day
Averaged 80,000 tests a day over past week
- LA County 517,000 + 138,000 *23,000 Daily Avrg*
California 1,736,894 + 336,894 *56,000 Daily Avrg*
- LA County advises to contact your primary provider about testing at their facility as more private providers are offering testing
- Testing is now available for asymptomatic individuals



Fire Department

- No changes to Fire Department operations or staffing
- 4-6 months of PPE's - Including supplies to support all City Department's during re-opening process
- Calls for service remain at normal levels
- Approximately 10%-15% of EMS calls are suspected COVID-19

Covid-19 Update

State Revised Order Monday

- Now permitted:
 - With approval of County health department
 - All retail with in store service
 - Worship services
 - Personal care
 - If County can meet criteria for variance
 - Dine in restaurant service
 - If County can meet criteria
 - 47 of 58 counties have met criteria

County Revised Order Tuesday

- Beginning to align with the State
- All retail now open
 - In store service, not just curbside
 - Effective today
 - 50% capacity
- Library take out service
- Worship services
 - Less than 25% of occupancy of max 100 people
 - whichever is lower

County Revised Order

- Offices
- Flea markets, swap meets
- Drive-in movie theaters
- Pools, hot tubs, saunas in multi-unit residences

- Physical distancing, masks and other protocols remain in place

County Variance

- Applied for variance for entire County
- Met criteria as of this week
- If approved, would permit:
 - Personal services (nails, hair, barber, etc.)
 - Dine in or outdoor dining
- Specific protocols for each industry

Restaurant Reopening

- Possibly by June 15
- State guidelines:
 - No specific seating capacity reductions
 - Achieve social distancing in variety of ways
 - Reservations
 - Outdoor seating
 - Bars remain closed, remove extra seating
 - Disposable menus, online ordering
 - No common items such as salt and pepper
 - Masks for employees
 - No waiting areas
 - Employee safety protocols
- Safety checklist; business to self certify
- Relaxed temp sign regulations
- Considering additional outdoor patio seating
 - Next Council agenda

Library Takeout Service

- Goal: Launch June 8
 - Materials requested through catalog, over the phone, or using Materials Matchmaker online form.
 - All materials checked out in advance and bagged in preparation for no-contact pick-up at door.
 - Customers notified by phone about Library Takeout orders ready for pick-up.
 - No customers allowed in the building.
 - Physical distancing measures and masks enforced.

City Hall Reopening

- Adopt a plan and policies
 - Office guidelines posted by County yesterday
 - On Council agenda June 17
 - Open July 6
- Other Preparations
 - Staff training on protocols
 - Sneeze guards on backorder
 - Move desks for 6 foot spacing
 - Adequate cleaning supplies
 - Service HVAC system
 - Will be replaced in coming months

Social Distancing Priority

- Virtual meetings remain standard
- In person services by appointment only
 - Only if circumstances require
- One member of the public at a time
- Queue spaces outside if necessary
- No conference room meetings

Telecommuting Will Continue

- County order mandates continued telecommuting where services can be provided remotely
- Protocols require limiting face to face contact as much as possible
- Social distancing requires less people in the building
- Investment in technology allows remote services
- Staff to work alternating schedules
 - Two days telecommute, two days in office

I hope you, your family and your colleagues are safe and healthy. On behalf of the residents of Bonita Drive in South Pasadena, I want to convey how appreciative we are of you and your staff's efforts in prioritizing the security of the vacant lots in our neighborhood.

Many residents, even South Pasadenans, do not know our neighborhood very well. Located in a small hillside area, the area is a combination of small single family residences on small lots and apartments. The turn over is low and we know each other pretty well. Initially, my neighbor, Linda Esposito, noticed peculiar and suspicious behavior on her side of Bonita Drive. Luckily, our community sprung into action and with the support of Mayor Bob Joe, City Manager Stephanie DeWolfe, the South Pasadena Police Department, CHP and your office, Assemblymember Holden, our

neighborhood warded off potential squatters in the vacant CalTrans homes on Bonita Drive.

I also appreciate your efforts in having the CalTrans not only boarding these vacant, dilapidated homes, but boarding them from the interior of the home. It would have created more of an eyesore if they were boarded up on the outside.
