There is no word limit on emailed Public Comment. Public comments will only be taken for items on the special agenda (no general public comment). Please make sure to indicate: 1) your name, and 2) what special agenda item you are submitting public comment on.

Pursuant to state law, the City Council may not discuss or take action on issues not on the meeting agenda, except that members of the City Council or staff may briefly respond to statements made or questions posed by persons exercising public testimony rights (Government Code Section 54954.2). Staff may be asked to follow up on such items.
