## Background

- Homeless Count in South Pasadena
  - 2017: 11 persons
  - 2018: 22 persons
  - 2019: 34 persons
  - 2020: 15 persons



- 90% of the homeless population in South Pasadena are male adults and 10% are female adults.
- 10% of the South Pasadena Police Department's calls for services are regarding homeless individuals.



### Plan to Prevent & Combat Homelessness

- In 2017, the Los Angeles County and United Way awarded a planning grant to the City of South Pasadena (\$30,000).
  - 3 three input sessions
  - Interviews
  - Key stakeholders
  - Develop goals and strategies
  - Alignment with the County's Board of Supervisors Homeless Initiative strategies





# Measure H Grants

- Only cities with a Homelessness Plan were eligible to apply.
- City of South Pasadena received 3 separate awards
  - **\$60,000** Housing Policy Efforts: Gather community input on updating the Accessory Dwelling Unit Ordinance, Development of an Inclusionary Housing Ordinance, Relocation Fees for Renters & a Rental Inspection Program.
  - **\$115,000** San Gabriel Valley Regional Housing Trust
  - **\$292,000** Motel Vouchers, Rapid Rehousing & Case Management (*Joint Award with the City of Arcadia*)
  - Ends: December 2021



## SGVCOG Homeless Plan Implementation Grant

- The City of South Pasadena applied for and received the maximum allocation of \$165,000
  - \$82,000 Motel Vouchers & Housing Navigator
    - Ends: May 2022
  - \$68,000 Variety of Activities
    - \$15,000 3 Encampment Clean-Ups
    - \$20,000 Law Enforcement Outreach
    - \$20,000 Education through Workshops & Video Development
    - \$13,000 Port-a-Potty & Handwashing Station
    - Ends: May 2022
  - **\$15,000** Prevention & Diversion
    - Ends: December 2021






# **Causes of Homelessness**



- 59% of people in LA County cited economic hardships as the cause of homelessness
- 600,000+ people in LA County pay more than 90% of their income on rent
- African Americans make up 9% of LA County residents, but 40% of LA's homeless population
- Because of COVID we expect to see an increase in homelessness
  - 1 in 10 individuals in owner-occupied households have fallen behind on mortgage
  - 1 in 6 have fallen behind on rent

## UNION STATION HOMELESS SERVICES

### **2020 DATA/OUTCOMES**

 62 unique individuals enrolled in the outreach & housing navigation (i.e. received services) from March 2020-February 2021

10 individuals matched to a permanent housing resource;
2 individuals moved into permanent housing

- 14 referrals to interim housing attained (including motel vouchers)
- 12 individuals served through Motel Voucher Program
- 4 individuals served through Rapid Rehousing Program

### LAHSA Reform

### **Funding Advocacy**

- FY 21-22 Measure H Funding Recommendations Released
  - \$1 million in gap funding for City contracts until December 31, 2021
    - \$250,000 for the San Gabriel Valley
  - \$5 million for LA County Councils of Governments for FY 21-22, then \$10 million for FY 22-23, total of \$15 million over 18 months
    - SGVCOG would receive \$3.75 million to continue homelessness
       programming from Jan 2022 to June 2023
  - Public comment period ends Thursday, May 6

I'm reaching out to <u>share a letter from Abundant Housing</u> <u>LA and YIMBY Law to HCD Director Gustavo Velasquez, regarding South Pasadena's</u> <u>draft housing element</u>. As you will see, our letter expresses major concerns about the City's intended approach to updating the housing element. We believe that the City's intended approach does not satisfy the intent of state law, which is to expand housing availability at all income levels.

Re: Proposal to Enact Update to Accessory Dwelling Unit (ADU) Ordinance

Dear City Council Members, and City Attorney,

The California Renters Legal Advocacy and Education Fund (CaRLA) submits this letter to inform the City Council that they have an obligation to abide by all relevant state housing laws when evaluating this ordinance to update South Pasadena's ADU standards. The ordinance as currently proposed presents numerous conflicts with state ADU standards. If the Council fails to amend the ordinance to resolve these conflicts, South Pasadenawould lose the ability to apply any development standards to ADU permits, and be forced to apply only the state minimum standards. (Gov. Code Section 65852.2(a)(4).)

California's statewide ADU standards were first adopted in 1982 in order to promote the development of Accessory Units as a way to combat California's massive housing shortage. In the decades since it was first adopted, the standards have been strengthened repeatedly, due to cities like South Pasadena that have resisted making any effort to promote housing growth. Most recently, the state adopted a package of legislation to further strengthen state ADU law and limit local discretion to impose development standards and deny ADU permits. The reasoning behind this level of state intervention in local development policy is clear. In order to address our state's massive shortage of housing, we must find every way we can to create new homes. ADUs are one of the easiest ways to accomplish this goal. ADUs are the most affordable types of housing we can create without involving government subsidy. ADUs also maintain the existing appearance of neighborhoods, as they are most often developed in backyards or converted from existing structures. If there is one type of housing development that should generate the fewest objections by local neighbors and city governments, it is ADUs. Local governments that continue to resist ADU development make clear that they are uninterested in helping to solve the housing crisis.

#### I. The proposed ordinance violates Gov. Code Section 65852.2

This proposed ordinance would be more restrictive than is permitted under the state ADU law in a number of ways:

- **High Fire Risk Zones:** The city proposes to define high fire risk zones as covering nearly three quarters of the city's land. Fortunately, the proposed ordinance would not ban ADUs in these areas, but instead proposes to impose costly additional development standards on ADU permits in these areas. While fire risk is an important public safety concern in California today, the city's reasoning behind these standards is unconvincing. Specifically, the city does not establish why adding ADUs to an area characterized by large lots and low density would increase fire risk when compared to the single family homes that are already allowed in this area.
- **Discretionary Permitting Requirements:** The ordinance proposes to require that "Prerequisite Discretionary Permits" must be completed before an ADU application can be deemed complete. This requirement subverts the mandate in state ADU law requiring an entirely ministerial permitting process. If an ADU applicant must first complete a discretionary hillside permit review with public hearing prior to filing an ADU permit application, that is not a ministerial process, and would not conform with the 60 day permitting requirement. South Pasadena is permitted to consider tree removal, historic preservation, and hillside development in its ADU ordinance, but it must do so in a ministerial manner.
- **Ten Foot Building Separation:** The ordinance proposes a 10 foot building separation requirement for detached ADUs. If this requirement is included in the ordinance, it must include an exception for ADUs 800 square feet and under Gov. Code Section 65852.2(c)(2)(C).
- Development Standards Applied to Exempt ADUs: Gov. Code Section 65852.2(e)(1) outlines a series of categories of ADUs that are entirely exempt from local development standards. These "exemption ADUs" cannot be subject to additional local standards such as parking, floor area, and lot coverage. While some sections of the proposed ordinance seem to acknowledge this requirement, in other areas the ordinance attempts to apply local development standards to ADUs falling into these categories. For example, parking requirements are imposed on new ADUs in multifamily buildings, when none are allowed. The ordinance should make clear that all ADU permits covered by subdivision (e) or the state standards are exempt from otherwise applicable standards in the local ordinance.

We ask that the City Council reconsider these issues and amend the ordinance.

#### II. South Pasadena should embrace ADU development.

Rather than taking the approach outlined in this ordinance, South Pasadena should consider the benefits of embracing ADU development. ADUs and JADUs are low-impact, affordable sources of new housing that will help address California's housing shortage without disrupting existing single-family neighborhoods. They can

provide flexibility for multi-generational families or older homeowners seeking to age in place.

The current housing shortage in California makes all housing more expensive, forcing people to share smaller spaces in order to afford a home, or leaving people without the means to afford any shelter at all. With more homes available, we would have less overcrowding, and people would be able to afford more space and have more secure living situations. Not only is South Pasadena's proposed ordinance illegal, it would exacerbate the very problems that the Council is seeking to solve. We at CaRLA hope that the Council considers amending the ordinance. CaRLA is a 501(c)3 non-profit corporation whose mission includes advocating for increased access to housing for Californians at all income levels, including low-income households. Item #13: Appointment of ad hoc City Council Subcommittee for Implementation Strategies regarding CalTrans surplus properties disposition (Phase II)

Mayor Mahmud and City Councilmembers,

Please seriously consider appointing Councilmember Primuth and Councilmember Cacciotti to the Phase II ad hoc subcommittee tonight. This ad hoc committee critically needs both councilmembers to be a part of the potential negotiations with CalTrans, the creation of a land trust and also the financing strategies for the purchase of surplus properties.

Councilmember Primuth has the largest number of CalTrans properties in his district and Councilmember Cacciotti has an inordinate amount of local, legislative and legal expertise dating back from the "710 Freeway Fight" to his work as a deputy attorney general for the State of California, specifically in the Department of Transportation. Michael has worked with and is a personal friend of Mike Roos who was speaker of the house and most


recently worked with our city on our freeway fight.
