Here are a few questions we're hoping will be covered: As your first major action as city manager, what will you look for in a Police Chief? To what degree will you engage public participation in the selection of a police chief? What strategies or methods would you implement to hold the police chief accountable to following the department's own policies and procedures? How should a police chief and their department respond to changing public opinion about the role of policing, specifically to replace significant parts of today's police function with alternatives approaches to public safety? For instance adopting a CAHOOTS style program (reallocating some police department budget to social welfare and homeless services). In what ways would you commit to transparency and community outreach? What goals would you set to advance social and economic justice and environmental programs in South Pasadena and how would you seek to achieve them? For instance; new city hires to handle environmental programs, enforcement of affordable housing development and creating a Homeless & Housing Resource Center administered by the city. What should the city do to limit cut through traffic in neighborhoods and better engineer traffic controls to promote pedestrian, bicycle, and motorist safety? Have cities relied too much on privatizing services once performed in-house with city employees? To the extent services are privatized, should they involve contractors who are local or at least in our region, versus sending our money to North Carolina, Fresno, and other places?
