Black Lives Matter Mural at Orange Grove Park

Attached is an additional document which provides the South Pasadena Public Library's response, dated July 20, 2021, to the Anti-Bias Club's request to locate the proposed mural on the exterior wall of the library.

Dear Lulu, Khalil, Maya, and Noah,

Thank you for waiting patiently for a reply while we worked through issues and questions related to your request that the City's Library host the Black Lives Matter mural sponsored by the SPHS Anti-Bias Club on our building's exterior.

As you know, at their June meeting, the Library Board discussed the request and determined that there needed to be a policy in place that would address art display and art donations before they could consider any proposal. Between the June and July meetings, Library staff collected examples of art display policies from other libraries, but we found none that addressed exterior artwork specifically.

At the July meeting, the Board discussed the idea of exterior murals generally and the Black Lives Matter mural specifically. Board members did not support the idea of an exterior mural at the library. Because the building exterior has a finite amount of space, it will never be possible to equitably represent the many contemporary topics that might be proposed for display. They discussed what they would wish to see included in a future policy related to art display on the building exterior, and the following key criteria were identified. Artwork should:

- Have a literary or library theme in keeping with the existing exterior artworks and decoration:
 - o Author name engravings around the historic Community Room
 - Bronze sculpture by Leo Politi (depicts children reading)
 - o "The Children's Hour" by Merrell Gage (depicts children being read to)
 - o Merrell Gage Reliefs (depicting Don Quixote, Rip Van Winkle, Hamlet, etc.)
 - Merrell Gage sculpture (legend of St. George and the Dragon)
- Be removable/non-permanent or of a temporary nature (i.e., a short term exhibition)
- Be easy and inexpensive to maintain and resistant to vandalism

While the Board will not recommend to City Council that the Anti-Bias Club sponsored mural be located on the Library building, they appreciate having had the opportunity to consider your proposal. The discussion about art display that your request prompted was a useful and important one.

The library recognizes the significance of the Black Lives Matter movement, and will continue to give everyone an opportunity to expand their knowledge and experience the voices and stories of BIPOC through our collections and programs. We also welcome collaboration with the Anti-Bias Club that aligns with library services. If the Club wanted to hold a forum with the artist to get community feedback about the design, or display a small scale reproduction of the design indoors to engage the community, we would be happy to discuss these or any other ideas you might have.

Councilmembers,

So to finish the thought, I propose the following sample tasks as an alternative to a small-town city government agenda focused on global health and the direct control of the planetary climate:

- 1.) The library is still operating with reduced hours and staffing compared to pre-pandemic levels. Fully re-open the library to the pre-pandemic standard. I'm using the library wifi to write this, and in the ten minutes I've been sitting here, six people have walked up to the front of the library and tried the door. People expect the library to be open before 1:00, and should expect that.
- 2.) In much of the country, the standard of coverage for fire and EMS services starts with one company and station per 10,000 people. South Pasadena is already far below that standard, but now proposes substantial growth, in part because of our RHNA target. Begin planning to fund a second paramedic-staffed engine company.
- 3.) Arroyo Park is always covered in graffiti. Develop a plan to routinely clean it up, and work to prevent it.
- 4.) Orange Grove, between the 110 and Columbia Street, continues to cause concern to neighbors. Slow the traffic there.
- 5.) Accelerate new housing starts.

Clean parks, fully functional library, sustainably excellent police and fire services, some new housing. When you can do these things and succeed at them, turn to controlling the climate of the planet with the godlike powers you no doubt possess. Manage South Pasadena well, and then turn your attention to exerting the vastness of your global power. Run the city.

Councilmembers,

If we were to play a game in which I issued the challenge, "Tell me you live in an affluent community on a six-figure pension without telling me you live in an affluent community on a six-figure pension," you couldn't give a better response than the current policy direction of our city government. Yes, Karen, we're all very concerned about making sure orange peels are properly sorted in the garbage cans – it's really one of the most pressing issues facing Americans in the current economic environment.

The preciousness of the city's emerging policy focus is becoming laugh-out-loud funny, but the *context* in which that preciousness is set is increasingly remarkable. Housing prices are becoming dangerously high in a county that already has shocking levels of homelessness, energy prices of all kinds are crushing the household budgets of low-income families, growth in food prices is rapid and unchecked, and many communities – so far not this one, but we're all watching – are experiencing a disturbing growth in violent crime and organized retail thefts. I thought the recent footage of rail lines near downtown LA littered with stolen cargo and discarded packages were a neat summary of the current sense in our country and our state of an implosion in routine order and social function. Basic things aren't *working*.

In that environment, you've casually chosen to increase energy prices for local businesses (which will pass the cost increase to customers), you're focused on *electric cars* for police, you're looking closely at how we sort garbage, and – unconscionably – you're about to vote to destroy a successful business, Fair Oaks Cigars. I thought the most telling line in the staff report on the tobacco ban was the one telling you that the only other cities that have done what you're proposing to do are Beverly Hills and Manhattan Beach. That's your clue that you've descended into the virtue-signaling hobby politics of affluent suburbanites.

Go walk around Fresno or or Blythe or Bell – or Garvanza – and tell people on the street that you're *desperately* concerned about cigar smoking and improper trash sorting. Please record the resulting discussions for my entertainment.

I grew up in Los Angeles in the 1970s, so I grew up breathing gray soup. I appreciate a focus on environmental issues, but balance and context matter. I promise you we have families in South Pasadena who are struggling to pay bills, and every policy choice you're making makes basic elements of daily life more expensive: energy, groceries and household basics, trash service, taxes. The city that recently increased the local sales tax – a regressive tax that hits low-income people the hardest – wants to increase trash pick-up costs to make sure we get bespoke handling for our organic waste. "This discarded arugula has not been properly managed!" Seriously, bless your little hearts. I substantially edited that last sentence for the sake of politeness.

South Pasadena is a small and affluent community that has, so far, mostly had the good fortune to ride above much of the social and economic disorder emerging in much of the country. But let's not assume our luck will hold.

The essential social order is falling apart. Fall back on core functions. Ensure rapid and effective police and fire response. Keep the streets and parks clean and well-maintained. *Get new housing approved and underway*. New housing, new housing, new housing. No one with an annual income below the cost of a Maserati gives a shit about sorting the trash.

And for crying out loud don't kill the cigar store. Someone built that – spent years of their lives making it, growing it, running it, nurturing it. You get to kill it as casually as *voting* that it has to die? Shameful.

You should get out more.

Making the one lane street into a 2 lane street would increase the speed of the cars driving down Orange Grove and increase the number of accidents and severity of the accidents. The problem with this street is that the merge happens on a curve going downhill after Oliver street.

What should actually happen is the Orange Grove Blvd median should be revised between Columbia Street and Oliver street so that the two to one merge happens at this location. This would make the street MUCH safer and also cost a TON less than \$500k.

Dear Councilmembers,

I am writing to comment on Agenda Item 15 regarding the Proposed Project List for Measure M.

Project 1: Orange Grove Avenue Widening from Oliver Street to Arroyo Seco Parkway

I strongly oppose this project. From my understanding this would remove the sidewalk along a section of Orange Grove Ave. I frequently run in this area and bike with my children. The sidewalk provides a safe route through a high traffic area.

The project description states: "Significant negative impacts to pedestrian usage of the parkway are not expected, as there exists a wall along most of the route, where no homes are fronted on Orange Grove Avenue."

There is no study to support this, and it is absurd to think sidewalks are only needed directly in front of homes. Sidewalks should allow for continuous travel. Without a sidewalk, pedestrians will be forced to cross to the east side of the street. This would be inefficient and dangerous. Furthermore, it would omit people from walking to and from the adjacent neighborhood between Sterling Pl and Hermosa St.

The existing sidewalk and landscaped parkway is a scenic and enjoyable part of South Pasadena. Replacing a sidewalk with another vehicle lane would compromise pedestrian safety and community mobility. It is an expensive project with a negative impact. The extra lane also appears to be unneeded. At rush hour this evening, we observed no queue for the right turn to the 110 Fwy.

For your reference, attached is a photo of the subject sidewalk in use.

Project 3: Garfield Avenue and Monterey Road Traffic Signal

If a traffic light is installed, it should include a pedestrian signal and flashing beacons. A pedestrian button should give priority over the vehicle traffic.


Project 5: (item 5) Huntington Drive at Wayne Street marked crosswalk removal, as it lacks pedestrian controls, and there is not a bus transit stop at this location.

I live near the location and use this crosswalk regularly. It is difficult during busy hours, but it times well between the stop lights at Fletcher and Garfield. Without this crossing it will be a much further walk for residents to get across Huntington to the local grocery store, shops, and restaurants. If pedestrian controls are needed, they should be added, but we should not remove a useful crosswalk from the community.

These two investments alone will cost nearly \$1M and to bring faster cars and unpleasant sidewalks. No thanks!

Why not install some no-brainer projects that actually improve safety and promote sustainable transportation and are the product of community engagement- like the many bike lanes identified in the city's Bike Plan! Some of these can even be installed without parking loss or lane removal (though personally I have no issue with losing some parking or travel lanes for the name of safety and the environment).

Like why doesn't South Pasadena put bike lanes on Monterey that connect to existing bike lanes on Monterey in the City of LA? Or close that ridiculous small bike lane gap between the York Bridge and the bike lanes on Pasadena Ave? Dear Council,

I currently serve as a commissioner on MTIC, and I am writing to express my concerns with and opposition to two projects identified on the Proposed Project List for Measure M MSP funding:

- Orange Grove Bl Widening: This project would increase the number of southbound travel lanes by removing
 portions of the landscaped parkway along Orange Grove Bl and the ornamental pedestrian-scale lighting. No
 studies have been completed or even a SWITRS report requested to support this recommendation, and
 community outreach has not been obtained. The City shouldn't request funding for this project without a clear
 understanding of the safety implications and project outcomes.
- <u>Garfield Av/Monterey Rd Traffic Signal:</u> Similarly, a traffic study (i.e., traffic signal warrant) has not been completed for this signal. The City of San Marino, with whom the signal would be jurisdictionally shared, has not agreed with this recommendation. Further, the signal may improve the efficiency of the intersection, making Garfield Av and Monterey Rd a more attractive option for vehicular traffic.

The City has many unmet active transportation needs (i.e., implementation of the feasible Bike Plan elements and Citywide pedestrian infrastructure enhancements) that would be better suited for these funds to enhance the safety and sustainability of our community.

Dear members of the South Pasadena City Council,

I'm writing you today to address agenda item 15. I'm Samuel Zneimer, former resident, former MTIC chair and transportation advocate. As you know I care deeply about improving the South Pasadena, with a focus on transportation and climate change. Tonight, you have the opportunity to commit to the goals climate action goals and the multimodal future we have discussed for decades in South Pasadena. While we have spent millions on road projects and have future commitments of tens of millions for highway/ITS improvements, but yet minimal funds dedicated to improving active transportation. How will we ever encourage walking and biking if we won't commit to the infrastructure that makes people safer? I've heard the promises that we would fund these projects when funds are available, here is your opportunity to fulfill those promises and to fund projects that have been approved by City Council and help us achieve our climate action goals and the multimodal future we have been fighting for.

Below is additional information about projects on the City's current list and about potential projects that can be substituted that have been studied, outreach was formally conducted and approved by City Council. There are several projects on the City's current list for the AVCJPA Measure M Multi-year Subregional Program are inconsistent with the City's adopted Climate Action Plan and commitment to public safety and public health. These include the proposed widening of Orange Grove Boulevard (\$500,000) to two lanes which would require the removal of the landscaped parkway between Columbia and Arroyo Parkway, and the proposed Garfield Ave / Monterey Road traffic signal (\$400,000), which would encourage more traffic and speeding along this corridor. Traffic studies have not been completed for these projects to understand safety impacts, and there has been limited to no outreach conducted to inform their development.

At the same time there are a number of projects that the City has formally studied and vetted with the community, yet remain unrealized. There's no time like the present to invest in safer, healthier streets. Cities and counties around the region, United States and world have accelerated investments to help address dangerous street design, air pollution, and the climate crisis over the past two years. The City of Arcadia installed over 9 miles of bikeways in June 2020 despite having never adopted a local bike plan.

This agenda item is an opportunity for the City Council to advance the City's 2021 Climate Action Plan and 2011 Bike Plan in one fell swoop. To Whom It May Concern:

The purpose of redistricting is to adjust the City's district lines to shifts in demographics. The data used to redraw the map are from the most recent Census. Per the City's website, this process is required by State law, the California Voters Rights Act, and should be guided by the spirit and intent of that law and not the desires or political conveniences of City leaders or even certain members of the public.

Cities are to "draw their district lines to reflect how local populations have changed" however not knowing exactly what those changes are, South Pasadena Tenants Union opted not to submit a public map but instead to provide our feedback on those submitted by the public as well as the NDC maps. It is our goal to take a position that, in a small city such as ours, it is still possible for all people to be equally represented by balancing each district economically and racially.

In review of all the maps, we find Public Map 105 to be the most democratic.

In comparing Public Map 105 to the current map, all other public maps and the NDC maps, the equal distribution of race, income and renters creates the most equality across the board with low income residents, renters and the various racial communities, almost equally represented in each district. This balance creates accountability to these groups by the entire Council. (We recognize that because of the nature of the types of dwellings which are district to District 4, it will always have a majority of renters.)

In contrast, the other maps represent disparities based on race and income by creating three districts with larger white and wealthy populations. This leads to an imbalance of power on the Council which is the exact opposite of what the State law has intended.

When the poor, people of color and renters are corralled primarily into two districts, our issues are outnumbered two to three every time. As advocates for the low income, workers and renters in South Pasadena, we have had to work three times as hard to be heard by the council as have environmental and traffic advocates who are mostly white and upper income.

Public Map 105 appears to be an effort to truly balance the political, economic and racial scales of City Hall. While it is tidy to draw maps which visually "make sense", it's politically and socially just to draw maps which live up to the spirit of the California Voters Rights Act and do not disenfranchise the poor and people of color.

We assume that it is as unacceptable to our City leaders as it is to us to have two districts with less than 18% low income when it easily possible to draw lines in which each district has between 18% and 24% percent low-income residents. Renters make up 52% of our population in both multi and single family homes in all neighborhoods of the City. Yet, all other maps, including the current map, have renters jammed mostly into two districts also creating at least two districts with fewer renters and more wealthy homeowners. As is illustrated by Public Map 105, which is geographically very similar to the current map, economic and racial balance across each district can be achieved.

South Pasadena Tenants Union looks forward to working with our city leaders to redistrict South Pasadena in the most democratic and socially just way possible. We put our trust in those who were elected to lead our city to uphold our democratic ideals and liberal values. Dear South Pasadena City Council,

The American Academy of Pediatrics California Chapter 2, which represents pediatricians in southern California including South Pasadena, is in <u>full support</u> of the ordinance amending Chapter 18, Article VI of the South Pasadena Municipal Code to prohibit the sale of all tobacco products and electronic smoking devises.

No amount of tobacco is safe tobacco. Tobacco use is the leading cause of preventable death and illness within the United States and claims more than 440,000 lives each year. The majority of adult smokers initiate tobacco use before the age of 18. In fact, the connection between children and tobacco use is so strong that the Commissioner of the US Food and Drug Administration (FDA) declared smoking a "pediatric disease" in 1995.

E-cigarettes specifically are the most commonly used tobacco product among youth and per the 2016 US Surgeon General's report are unsafe for children.² E-cigarette products are typically advertised to youth by using flavored, such as fruit or candy, products. Further, there is strong evidence that youth who use e-cigarettes are significantly more likely to later use traditional or combustible cigarettes – a product that goes on to kill its long-term users.² And more recently was the emergence of e-cigarette, or vaping, product use-associated lung injury in teenagers, a devastating and completely preventable disease.³ As long as e-cigarettes are still accessible, they pose a substantial threat to children's health.

If we can limit the number of children and adolescents who use tobacco products, we can improve child health and over time, reduce adult tobacco use. Prohibiting the sale of combustible and electronic tobacco products is an essential step in protecting our children and broader society. Thank you for your dedication to children's health and for your future support on this ordinance.

RE: Proposed Ban on Tobacco Products Sales

Dear Mayor Cacciotti and Councilmembers:

As the Executive Director of the National Association of Tobacco Outlets (NATO), a national retail trade association that represents more than 65,000 retail stores throughout the country including several South Pasadena retail stores, I am writing to submit our comments and concerns regarding the Tobacco Retail Sales Ban which is Agenda Item 17 for your March 2, 2022 meeting. As this is a ban on all tobacco products, except cigars in the single cigar lounge in the city, it includes a ban on tobacco products that have been determined by the U.S. Food and Drug Administration to be "appropriate for the protection of the public health." We would ask that the City Council not adopt this ordinance for the reasons explained below.

Store Closures and Layoffs Will Likely Follow the Ban: Our convenience store members recently experienced losses of up to 45% in gasoline sales and 20% or more in grocery, snack, beverage, and tobacco product sales during the recent market disruptions. These sales losses are significant numbers because convenience stores usually rely on tobacco product sales for approximately 36% of in-store sales. We note that the staff memorandum merely states that "some have estimated between 15-20% of their revenue is from tobacco sales." This may be true for "some," but it is not true for the average convenience store.

Moreover, the profit margin for the sale of tobacco products exceeds that of many other products, including food and gasoline, so even if a grocery store or gas station only had 15-20% of its revenue from tobacco, that represents a larger part of their profit. For this reason, the 8-month amortization period is unfairly small. Even those stores that could show hardship would have only 20 months of amortization, too short of a period of time to adequately compensate them from this profound regulatory prohibition. This may well result in costly litigation for the city and its retailers, costs the retailers do not wish to incur in light of not only the recent losses they have suffered, but the recent payroll cost increases they have incurred to attract and retain employees and as a result of inflation.

If South Pasadena retailers must remove all tobacco products from their shelves, it will be very difficult to compete with retailers in neighboring localities, as those retailers will be able to provide tobacco products plus the market basket of other goods and services those customers purchase while at retailers in other cities. South Pasadena retailers will also not be able to compete with illicit sellers who do not care to whom they sell their products. Employee layoffs and store closures are real possibilities, particularly for gas stations and convenience stores, and grocery prices may need to rise to offset the lost profits from tobacco sales.

South Pasadena Retailers are Responsible, Legitimate Businesspeople: NATO and its South Pasadena retail members share everyone's interest in keeping tobacco products out of the hands of persons under 21 years old, but banning all tobacco products for 21 and over adults makes no sense from a health standpoint or economic point of view. According to the FDA, retailers in South Pasadena have a 100% compliance record by refusing to sell to underage persons (see attached spreadsheet). The city is not making tobacco use illegal, so residents and others who purchase tobacco products in South Pasadena will simply go outside the city to legitimate retailers, or to the existing illicit market for cigarette products. There will be no positive health effect in South Pasadena. Why would the City Council want to harm South Pasadena's responsible, legitimate retailers and force their customers to other neighboring cities or to illicit markets when there will be absolutely no health benefit?

Low and Declining Use of Tobacco Products Makes Ruining Retail Businesses Unnecessary: In 2020, the Surgeon General's Smoking Cessation report stated that smoking had declined since the original 1964 Surgeon General's report on smoking and health from 52% to 16% among men and 34% to 12% among women, meaning smoking has declined over 60%. The figure in California is even lower, according to the California Department of Public Health, which found that only 10.1% of the state's adults smoked. Is it the least bit surprising that the polling figures in your staff report find that about 70% of people support phasing out cigarette sales, when only 10% smoke? What is more surprising is that 30% of people do not think that sales should be phased out, given that only 10% smoke. The polling numbers illustrate the classic case of the "tyranny of the majority;" those who do not smoke wish to force others to conform to their preferences.

As to youth, California's Healthy Kids Survey for 2019-2020 for South Pasadena Unified School District, only 9% of 11th graders had ever smoked a whole cigarette and only 4% had done so, even once, in the past 30 days; only 1% had ever tried smokeless tobacco and 1% currently use smokeless tobacco. (Contrast this with the same survey's finding that 30% of 11th graders currently used alcohol, 14% were currently binge drinkers, and 21% currently used marijuana.) The same survey found that in 2019, 16% of 11th graders currently used e-cigarettes; this figure should be considered in light of the CDC's recent findings that nationally, current e-cigarette use among high schoolers dropped about 60% from 2019 to 2021. See E-Cigarette Use Among Middle and High School Students — National Youth Tobacco Survey, United States, 2021, US Department of Health and Human Services, Centers for Disease Control and Prevention, Morbidity and Mortality Weekly Report, October 1, 2021, Vol. 70, No. 39. This means that the empirical data showing very low and declining underage use rates of traditional products in the South Pasadena and the national trend of a 60% drop in e-cigarette use does not support depriving all 21 and over adults their ability to buy tobacco products in South Pasadena.

FDA Intends to Ban Menthol Cigarettes and Flavored Cigars: The City of South Pasadena should not pursue a total tobacco ban because the Food and Drug Administration announced in April 2021 that the agency intends to publish a rule, expected by April 2022, to ban the sale of menthol cigarettes and all flavored cigars. With such a sweeping regulation, the city council should pause and allow the FDA's

proposed regulation process which the agency intends to ban some of the same tobacco products that would be prohibited under the proposed ordinance.

FDA Has Found Some Tobacco Products to be for the Public Health: The FDA has taken significant actions that have resulted in the removal of a substantial number of vapor products. In fact, the FDA has thus far rejected about 7 million electronic smoking devices which may no longer be legally sold in the entire country. However, the FDA is currently considering over applications for over 50,000 products as to whether they support public health. Thus far, it has granted applications for an e-cigarette, Vuse Solo, and cartridges used with that device; four flavored modern nicotine products, Verve Discs and Verve Chews in Blue Mint and Green Mint flavors; several General snus products; and some heat-not-burn products. The significance of these decisions should not be lost on the Council. For the FDA to grant those applications, it was required to and did find, after exhaustive scientific studies, that the marketing of those products was "appropriate for the protection of the public health." By granting these applications, the FDA has concluded that some tobacco products protect public health, and it is still working on applications for tens of thousands of other tobacco products. It would be premature for the city to issue a blanket ban on all tobacco products as the FDA may well grant marketing approval of other products as "appropriate for the protection of the public health." The city's ban on tobacco products would work against the public health benefits of those products.

We urge the City Council not to move forward with the proposed ban on flavored tobacco products. Thank you for your consideration.

Honorable Mayor Cacciotti and Councilmembers:

The County of Los Angeles is committed to protecting the health and well-being of youth and the general public. Cigarette smoking is responsible for more than 480,000 deaths per year in the United States. In California, 40,000 adults die annually from smoking, and 440,600 California youth now aged 17 and younger are projected to eventually die from smoking. Nearly all tobacco use begins during youth and progresses during young adulthood. More than 3,200 children age 18 or younger smoke their first cigarette every day.

Nationally the total economic cost of smoking is more than \$300 billion a year. In 2009, the cost of smoking in California totaled \$18.1 billion. This adds up to \$487 per state resident and \$4,603 per smoker. In Los Angeles County, tobacco use is directly linked to the top five causes of death: coronary heart disease, stroke, lung cancer, pneumonia, and emphysema. Smoking costs Los Angeles County \$4.4 billion in health care expenses and lost productivity from illness and premature death annually.

Consumer products containing chemicals proven to cause a severe threat to human health have been banned in the U.S. and are no longer marketable. Examples include lead, chlorofluorocarbons, and polychlorinated biphenyls, some of which are found in tobacco.

The 2009 Family Smoking Prevention and Tobacco Control Act specifically permits states and localities to prohibit sales of tobacco products. For instance, in California over 100 jurisdictions prohibit the sale of flavored tobacco products. This includes the County of Los Angeles, Alhambra, Pasadena, Manhattan Beach and Beverly Hills. In 2019 the cities of Beverly Hills and Manhattan Beach took the additional step of prohibiting the sale of all tobacco products, becoming the first and second jurisdictions, respectively, in the nation to adopt such policies.



Pediatricians in Support of South Pasadena Tobacco Sales Ban LOS ANGELES, CA (October 16, 2021)

Pediatricians support tobacco bans and urge the city of South Pasadena to pass a new ordinance to prohibit the sale of all tobacco products and applaud both Manhattan Beach and Beverly Hills for already taking this step to protect the health of children.

The evidence is clear that tobacco products are detrimental to the health and wellbeing of children and adolescents. Tobacco smoke exposure harms children from conception onward, either causing or exacerbating the risks of preterm birth, congenital malformations, stillbirth, sudden infant death, childhood obesity, behavior problems, neurocognitive deficits, wheezing, more severe asthma, more severe bronchiolitis, pneumonia, middle ear infection, reduced lung functioning, and cancer (https://pediatrics.aappublications.org/content/136/5/998). According to a 2014 US Surgeon General's Report, "If we continue on our current trajectory, 5.6 million children alive today who are younger than 18 years of age will die prematurely as a result of smoking."

Accessibility to tobacco products harms adolescents. A 2012 Surgeon General's report found that nearly 90% of tobacco dependent adults initiated their tobacco use well before their 18th birthday. Moreover, nicotine has been documented to be detrimental to the developing brains of children and adolescents.

Tobacco harms children. Smoke free legislation and bans on flavored tobacco are steps towards protecting children and adolescents from the harmful effects of tobacco smoke exposure and consumption. But we need to do more. Bans on the sale of all tobacco products will further limit accessibility, consumption, and the risk for second and third hand smoke exposure.

Dear Mayor Mahmud and Members of the Council:

The American Cancer Society Cancer Action Network (ACS CAN) is committed to protecting the health and well-being of the residents of South Pasadena through evidence-based policy and legislative solutions designed to eliminate cancer as a major health problem. ACS CAN supports efforts to reduce youth tobacco use and eliminating the sale of flavored tobacco products is an important part of a comprehensive approach to preventing youth from ever beginning a deadly addiction to tobacco. We support your efforts in eliminating the sale of all flavored tobacco products, including menthol cigarettes and Hookah, within the city of South Pasadena, and without exemptions.

Smoking remains the leading preventable cause of death in the U.S. The 2014 U.S. Surgeon General's report found that more than 43 million Americans still smoke. It is estimated that tobacco use will cause 480,000 deaths this year in the U.S. Both opponents of smoking and purveyors of cigarettes have long recognized the significance of adolescence as the period during which smoking behaviors are typically developed. National data show that about 95 percent of adult tobacco users begin smoking before the age of 21, and most begin with a flavored product. In 2009, Congress prohibited the sale of cigarettes with flavors other than tobacco or menthol. Tobacco companies responded by expanding the types of non-cigarette tobacco products they offer, and now make most of those products available in a growing array of kid-friendly flavors. Little cigars, smokeless tobacco, hookah, and e-cigarettes are marketed in a wide variety of candy flavors with colorful packaging and deceptive names that appeal to youth.

Adolescents are still going through critical periods of brain growth and development and are especially vulnerable to the toxic effects of nicotine. A study published in the journal, *Pediatrics*, found that the earlier youth are exposed to nicotine, the less likely they will be able to quit smoking. Tobacco companies have a long history of marketing to under-resourced communities, and target youth with imagery and by marketing candy and fruit flavored tobacco. The anesthetizing effects of menthol masks the harshness of tobacco, making it more appealing to people who are beginning to smoke, and people who smoke menthol show greater dependence, and are less likely to quit than people who smoke non-menthol. Postponing youth experimentation and initiation can help reduce the number of youth who will ever begin smoking.

Targeted marketing to communities of color, low income communities and LGBTQ communities adds to the health disparities in populations already impacted by social inequities. In African American communities, the tobacco industry has aggressively marketed menthol flavored tobacco products to youth. Approximately 85% of African Americans who smoke use menthol cigarettes, and consequently, African American men have the highest death rates from lung cancer, when compared to other demographic groups. The anesthetizing effect of menthol masks the harshness of tobacco, making menthol cigarettes more appealing to beginning smokers, and menthol smokers demonstrate greater dependence, and are less likely to quit. Presently, more than 70 jurisdictions in places as diverse as Yolo County, Contra Costa County, and the cities of Beverly Hills and Alhambra have passed strong policies.

While cigarette smoking has declined in recent years, the use of menthol and other flavored products have continued to increase, especially among young people and people who are beginning to smoke. We strongly encourage this council to move forward in drafting an ordinance, ending the citywide sale of all flavored tobacco products, without exemptions. Taking this important public health step will help to prevent young people in South Pasadena from ever beginning this deadly addiction, as well as help to support those who are trying to quit.

The County of Los Angeles is committed to protecting the health and well-being of youth and the general public. Cigarette smoking is responsible for more than 480,000 deaths per year in the United States. In California, 40,000 adults die annually from smoking, and 440,600 California youth now aged 17 and younger are projected to eventually die from smoking. Nearly all tobacco use begins during youth and progresses during young adulthood. More than 3,200 children age 18 or younger smoke their first cigarette every day.

Nationally the total economic cost of smoking is more than \$300 billion a year. In 2009, the cost of smoking in California totaled \$18.1 billion. This adds up to \$487 per state resident and \$4,603 per smoker. In Los Angeles County, tobacco use is directly linked to the top five causes of death: coronary heart disease, stroke, lung cancer, pneumonia, and emphysema. Smoking costs Los Angeles County \$4.4 billion in health care expenses and lost productivity from illness and premature death annually.

Consumer products containing chemicals proven to cause a severe threat to human health have been banned in the U.S. and are no longer marketable. Examples include lead, chlorofluorocarbons, and polychlorinated biphenyls, some of which are found in tobacco.

The 2009 Family Smoking Prevention and Tobacco Control Act specifically permits states and localities to prohibit sales of tobacco products. For instance, in California over 100 jurisdictions prohibit the sale of flavored tobacco products. This includes the County of Los Angeles, Alhambra, Pasadena, Manhattan Beach and Beverly Hills. In 2019 the cities of Beverly Hills and Manhattan Beach took the additional step of prohibiting the sale of all tobacco products, becoming the first and second jurisdictions, respectively, in the nation to adopt such policies.

Dear South Pasadena City Council,

The American Academy of Pediatrics California Chapter 2, which represents pediatricians in southern California including South Pasadena, is in <u>full support</u> of the ordinance amending Chapter 18, Article VI of the South Pasadena Municipal Code to prohibit the sale of all tobacco products and electronic smoking devises.

No amount of tobacco is safe tobacco. Tobacco use is the leading cause of preventable death and illness within the United States and claims more than 440,000 lives each year. The majority of adult smokers initiate tobacco use before the age of 18. In fact, the connection between children and tobacco use is so strong that the Commissioner of the US Food and Drug Administration (FDA) declared smoking a "pediatric disease" in 1995.

E-cigarettes specifically are the most commonly used tobacco product among youth and per the 2016 US Surgeon General's report are unsafe for children.² E-cigarette products are typically advertised to youth by using flavored, such as fruit or candy, products. Further, there is strong evidence that youth who use e-cigarettes are significantly more likely to later use traditional or combustible cigarettes — a product that goes on to kill its long-term users.² And more recently was the emergence of e-cigarette, or vaping, product use-associated lung injury in teenagers, a devastating and completely preventable disease.³ As long as e-cigarettes are still accessible, they pose a substantial threat to children's health.

If we can limit the number of children and adolescents who use tobacco products, we can improve child health and over time, reduce adult tobacco use. Prohibiting the sale of combustible and electronic tobacco products is an essential step in protecting our children and broader society. Thank you for your dedication to children's health and for your future support on this ordinance.

Statement Re: Negative Effects Upon the City of South Pasadena of Having Smoking and Vaping Materials for Sale / Readily Available to Youth and Adults

My name is Judith M. Harris, LCSW. I have been part of the South Pasadena community for the past 30 years. I raised a child who matriculated through all levels of South Pasadena public schools and have been integrally involved with the both the school and city communities over years. I am a mental health professional with both a private psychotherapy practice servicing children, adolescents and adults, and a private organizational consulting practice focused upon employee and organizational mental health and wellness.

An area in which I have acquired much expertise, and which is key to personal, workplace and community wellness is that of combatting addiction and substance use of all kinds. I have routinely taken many trainings covering the span of addictive and substance use disorders over years and have worked with scores of clients who present with a range of these disorders. Since 2019 I have taken a centration of substance use trainings sponsored by UCLA School of Public Health, University of San Francisco and the State of CA regarding smoking cessation. The use of combustible as well as vaping smoking materials is posing increased threats to the health and mental health of all populations in our state and country, but especially to youth. Vaping materials have been manufactured to target youth and are many times more toxic and dangerous to all who use them, but especially to youth since many times the amount of nicotine, a neurotoxin, and other toxic chemicals and metals particles, are delivered to the developing brain and body through vaping mechanisms. Youth, whose brains are in the process of developing are placed at high risk for developing mental health and other health issues as a result of vaping and smoking.

During the pandemic I notice many of my clients stagnating and sinking through delivery of my services over telehealth, so I devised a safe way of meeting with them in person in outdoor spaces. I have frequently met with clients in Garfield Park in secluded places including behind the Scout House. As I learned, this area has been a designated area in the park for local youth to use, drink and engage in sexual activities, apparently over the past 30 years. I have certainly found much evidence of all. Almost every time I have worked in the area, I have found evidence of youth having used smoking and vaping tobacco, marijuana, and other drug materials as well as their having used alcohol and marijuana edibles, and having in engaged in sexual activities, leaving unsafe, unhealthy discarded materials all over the area. This using/vaping youth population has also engaged in defacing public property including leaving graffiti on walls, the air conditioning unit by the Scout House, and carved into picnic tables! I have had to phone the So Pas police and Parks and Rec divisions on numerous occasions about what I am finding in areas of the park where I meet with clients. Of course, in order that areas in which I meet are not full of blight, I have become the "clean up crew" and "guardian" of the areas! In addition, the homeless population has been growing and many homeless persons are now living in Garfield Park, engaging in the same types of activities and leaving similar refuse in secluded areas of the parks such as behind the Scout House. It would be of great benefit to all in our community were the sale of smoking and vaping materials to be banned in the City of South Pasadena.

First Reading

Thank you for this opportunity. My name is Chris Bostic. I am an attorney with Action on Smoking and Health – or ASH – the nation's oldest anti-tobacco organization. Let me start with a short quote.

"Tobacco is deeply harmful to human health, and there can be no doubt that the production and marketing of tobacco is irreconcilable with the human right to health."

That comes from the Danish Institute for Human Rights, a respected organization with an international mandate to promote and protect human rights, and that previously had not been involved in tobacco control. They published this after conducting a human rights audit at the request of Philip Morris International, the world's biggest multinational tobacco company. Their conclusion has been echoed by over 150 public health and human rights organizations around the world. Some are represented here in the room.

"The production and marketing of tobacco is irreconcilable with the human right to health." That quote is important. It's clear that you want to do the right thing here – to end deaths and disease from tobacco use. You need to know that in spite of being a pioneer in this respect, South Pasadena would be on very firm ground, both morally and legally. Federal and state law allows you to do this. Human rights law, and general moral decency, suggests that you should.

I've been a foot soldier in the tobacco wars for 20 years, working mostly at the global level, so I come at this with a very wide lens. In some ways the world has made a lot of progress since I started, but the sad truth is that deaths from tobacco use are still going up, not down. We're looking at a billion deaths this century – that's billion, with a "b."

Tobacco killed over 8 million people last year, and the body count keeps rising. Nearly every advancement in the fight against tobacco, such as smokefree air, has started at the local level. This is not about a "nanny state," because it is about the behavior of the tobacco industry, not smokers. And it is not prohibition, because you are aiming at the sale, not use or possession. If the definition of liberty is the right to do whatever you want so long as it doesn't harm others, the actions of the tobacco industry in marketing its products do not meet that basic hurdle.

In particular, this comment is addressing the section of the ordinance regarding the exemption of cigar lounges from the ordinance, with certain conditions: 18.102 (b) (5) – (7). These specific conditions will preclude this long-term South Pasadena business from selling the business, relocating or closing for more than 60 days for any reason,(including any damage to the building due to unforeseen circumstances, such as earthquakes), or moving or expanding the square footage of the store. Hello City Council members,


My name is Chad Farah and I have owned Ocean Liquor since 2008. I want to urge you to reconsider this ban. Attached in this email is a map showing you the tobacco retailers outside our city and how close they are to the very center of our town. This ban will do nothing to hinder anyone from smoking considering how close tobacco retailers are just outside our border. The loss of tobacco sales are going to hurt the small business owners. Our main concern is the loss of customers who purchase other items along with tobacco. In a liquor store business, those sales are roughly a third of our sales. That would cripple us. If this was a statewide ban then maybe it would help deter the sales of tobacco however our 3.4 square mile town will do nothing for the goal of deterring tobacco sales to anyone living in the city.

I understand the concerns of the council, residents and various organizations that will be speaking today. I myself have 2 kids under the age of 8. I'm assuming this ban has to do with the fear of sales to a minor and not the tobacco users over the age of 21. I contacted the South Pasadena Police department to request records and information on any sales made to a minor since January 1st, 2000. They found in 22 years that zero tobacco retailers have been involved in selling to minors. I've attached the email from South Pasadena Police in this public comment as proof. The American Lung Association has given South Pasadena an A grade. We are 1 of 10 cities in all of LA county to receive that grade. With all due respect you are trying to find a solution to a problem that we do not have. I have spoken to other small businesses in the city and they all have practices in place to deny any sales to a minor. We here at Ocean Liquor scan every ID from any customer who looks under 30. I personally train every employee on the consequences of selling to a minor. Along with criminal charges and communicate with them that they would lose their job immediately. I have a zero tolerance policy towards any sales to a minor regarding tobacco and alcohol. This how I've stayed in business for 14 years.



This is Andrew Berk, Chairman of the Board of Directors of the South Pasadena Chamber of Commerce, and I'd like to provide comment on the tobacco item on the council agenda.

The proposal as it's proposed will severely and irreparably harm the 2 independent well beloved beer, wine and liquor stores and all of our independent gas stations:

- Tobacco retailers (liquor stores, gas stations, convenience stores, etc.) are abundant in adjacent cities, and in a city such as ours that's only 3.4 square miles, there are options in walking distance at each border. We will lose critical folks who will go buy all the other items they would have bought at our community retailers.
- People will not stop in 2 locations for tobacco and other purchases (they'll go where they
 can get both), which means not only loss of revenue from the tobacco, but all the other
 purchases, too. The city will also of course lose out on additional sales tax revenue.
- Abeverly Hills liquor store we have verified with, reports a drop of over 50% in revenue due to loss of customers to neighboring cities
- Small business is vital to South Pas these businesses are well established, long term and amenity well liked businesses
- There are already laws and codes in place to prohibit sales of these products to anyone under the age of 21 – the city should enforce these existing laws first, instead of piling on additional laws.
- The city should in the minimum delay this item and further review it and get community input. If the intent is to minimize flavored vaping to minors, then we feel strongly that the direction of such proposal should be much further clarified, defined, and limited to that scope.

Comments: Ordinance Ending Tobacco Sales in South Pasadena

Information Prepared by Malone Tobacco Policy Research Group, upEND Tobacco Project University of California, San Francisco

Ruth E. Malone, RN, PhD, Professor Emerita, University of California, San Francisco South Pasadena has taken a landmark step in proposing to become the third California city to pass an ordinance ending sales of tobacco products. As a researcher who has studied what is being called the "tobacco endgame" for more than a decade, I have been asked to provide some additional information for your consideration, and I am available to respond to questions.

The tobacco epidemic: An industrially created catastrophe

- <u>The tobacco epidemic is a phenomenon of the 20th century</u>. While tobacco has been used for centuries, it was only after the invention of the cigarette rolling machine in the late 1800s that the cigarette became the single most deadly consumer product in history, causing millions of premature, preventable deaths.¹
- The tobacco industry knew for decades that its products were deadly, but concealed the evidence from the public.²
- Globally, public health leaders have begun discussing how to end the tobacco epidemic.³
- The 50th anniversary edition of the U.S. Surgeon General's Report on the Health Consequences of Smoking suggests policies to do this, proposing "greater restrictions on sales, particularly at the local level, including bans on entire categories of products."⁴
- California is a world leader, with the second-lowest smoking prevalence of any US state after Utah.⁵
- If present progress continues, retailers will soon need to develop new business models that do not rely on tobacco sales.

Facts about smoking

- Smoking is the leading preventable cause of disease and death in the US, responsible for about 1 in every 5 deaths, more deaths each year than human immunodeficiency virus (HIV), illegal drug use, alcohol use, motor vehicle injuries, well-known microbial agents, such as flu and pneumonia (excluding the corona virus, which killed nearly 350,000 in the US in 2020),⁶ and toxic agents, combined.⁷
- In California, 40,000 adults die annually from smoking, and 440,600 California youth now aged 0-17 are projected to eventually die from smoking.⁸
- In 2009, the cost of smoking in California totaled \$18.1 billion: \$9.8 billion in healthcare costs, \$1.4 billion in lost productivity from illness, and \$6.8 billion in lost productivity from premature mortality. This adds up to \$487 per state resident and \$4,603 per smoker.⁹

 Smoking is concentrated among marginalized communities, including those living below the poverty level, sexual and gender minorities, and persons with mental health disorders, contributing to disparities in smoking-related disease and death.¹⁰⁻¹⁵

The retail environment influences smoking

- The ubiquity of tobacco outlets undermines a strong public health message that tobacco products
 are addictive and deadly, 16 and helps normalize smoking, suggesting that tobacco use is common
 and acceptable. 17
- Tobacco outlet density increases the likelihood of smoking among both minors¹⁷⁻²⁹ and adults,³⁰⁻³² and living near tobacco outlets is associated with unsuccessful quit attempts.³³⁻³⁶
- Tobacco use disparities have also been linked to the greater concentration of tobacco outlets in economically and socially deprived neighborhoods compared with wealthier neighborhoods.³⁷⁻⁴⁵
- Emerging evidence suggests that tobacco retailer reduction is associated with a decline in cigarette pack purchases.⁴⁶

Policy considerations

- The most fundamental purpose of consumer protection law is to protect people from hazardous products. The 1985 United Nations consumer protection guidelines state that "Governments should adopt or encourage the adoption of appropriate measures . . . to ensure that products are safe for either intended or normally foreseeable use." Any other product that caused the well-documented levels of death and disease that the manufactured, highly engineered modern cigarette does would have been recalled from the market decades ago.
- Sales of other legally sold consumer products that were found to be dangerous to the public have been phased out, including leaded gasoline, leaded paint and asbestos.
- The 2009 Family Smoking Prevention and Tobacco Control Act specifically permits states and localities to prohibit sales of tobacco products. 48 It does not allow the FDA to do so.
- Nationwide, support for a ban on tobacco sales within a ten-year time frame was 55% among nonsmokers and 33% among smokers in 2011.⁴⁹ In 2019, 52.8% of California adults agreed or strongly agreed that the sale of cigarettes should be gradually banned, while 37.3% agreed or strongly agreed that their sale should be immediately banned.⁴⁹

My name is Grace and I own a small business in the City of Beverly Hills. I am also not a smoker. We were the first city to ban the sale of tobacco. I wanted to share my views and experience of our tobacco ban.

Tobacco sales used to be approximately 20% of my sales. I've lost that stream of revenue and haven't been able to replace it. Although I can't quantify, I believe I have lost out on potential sales. Customers, new and old, used to come in regularly to purchase tobacco and then pick up other items with the tobacco. I've confirmed with former tobacco customers that they now drive a few blocks over to Los Angeles and to buy their cigarettes. I imagine they are picking up their snacks and beverages as well. New protentional customers will often times take a few steps into the store, inquire if we have tobacco and then immediately leave the store. I'm not given the opportunity to present my store, its merchandise and customer service, in hopes of a return customer.

My other complaint of the ban is that it is inequitable. We allow the hotels to distribute cigarettes to our tourists, but not the small business owners.

As you may or may not know, Beverly Hills is a non-smoking city. Smokers are allowed to smoke as long as they are walking. Smokers may not sit or stand in place. But the issue I have is there is no enforcement of this. If the message or intent is to create a smoke-free city and enforce this measure, I would be willing to support the city in its tobacco ban. But if the city is not willing enforce its own policy, I don't understand why small business owners should be punished for this.

However, in a drafted contract sent to us by the City Attorney, the two parties involved were the City and the School District, even though SPUSD does not enter into licensing agreements and contracting directly with our artist, Zach Brown, is the most effective method. Furthermore, our contract put the responsibility of maintenance entirely ours/Zach's, and if we didn't remove graffiti within 3 days, that was grounds for the City to terminate the contract and remove the BLM mural. The contract also included a clause saying the City could remove or relocate the mural for any reason, or no reason at all, at the sole discretion of the City."

For many years, the City of South Pasadena has used a consistent, fair, and equitable process for reviewing proposed public arts projects, involving the Public Arts Commission and the City Council. The proposed mural for Orange Grove Park has successfully gone through this process over the past several years, including several presentations before both the Commission and the Council.

Despite this extensive public input and approval, for some reason the City Council has chosen this mural -- a tribute to the strength of the Black community – as the one that calls into question the city's longstanding process for public art.

Since all of the previous public arts projects and murals throughout South Pasadena seemed to work fine using the current process, <u>I urge each City Councilmember to publicly explain to the community why they believe this mural should be handled differently.</u>

Countless other cities around the country have similar murals celebrating Black heroes and describing their experience. All of the people depicted on the mural appear on many public murals around the country.
