Recommendation

It is recommended by Mayor Cacciotti that the City Council appoint the following to City Boards, Commissions, and Committees:

Discussion

The South Pasadena Municipal Code section 2.23(a) states that, "Unless otherwise specified in this article, all boards and commissions shall consist of five adult members, all board and commission members to be appointed by the mayor of the city with at least three affirmative votes of the city council." Vacancies other than by expiration of a term shall be filled by the mayor, with approval of the city council, for the unexpired portion of the term. SPMC sec. 2.26(a). The term of office for commissions is three years for a full term, running from January 1 through December 31. SPMC sec. 2.25(a).

The City has continued community outreach to solicit applications to fill these and other advisory body vacancies. Upcoming vacancies occurring in 2023 will be posted on the City's website consistent with the Maddy Act. For residents interested in serving on a city advisory body, applications are available on the City's website or in the City Clerk's Office.

The applications are on file at the City of South Pasadena City Clerk's Office located at 1414 Mission Street, First Floor, South Pasadena, CA 91030.

SUBJECT:	Adoption of a Resolution Declaring the Results of the General Municipal Election held on November 8, 2022

Recommendation

It is recommended that the City Council adopt a Resolution reciting the fact of the General Municipal Election (Election) held in the City of South Pasadena (City) on November 8, 2022, declaring the results, and other matters as provided by law.

Background

On November 8, 2022, a General Municipal Election was conducted in the City of South Pasadena to elect members to the City Council (one in District 4 and one in District 5), one City Treasurer, and to submit to the South Pasadena voters a question of whether to extend the Library Special Tax (Measure LL).

In accordance with Resolution Nos. 7767, 7768, 7782, and 7783, the Measure was properly submitted to the Los Angeles County Registrar-Recorder/County Clerk (LACRR/CC), and the General Municipal Election was consolidated with the General Election conducted on the same day by the LACRR/CC. The ballots are counted, and the results canvassed and certified by the LACRR/CC.

Discussion/Analysis

The attached Resolution must be adopted by the City Council to officially declare the results of the Election and meet the provisions of California Elections Code Sections 10262 and 10263. The Los Angeles County Registrar-Recorder/County Clerk's Certificate of the canvass of the Election Returns and Statement of Votes Cast was received by the City of South Pasadena on December 5, 2022, and is attached (Attachment 1).

To maintain funding for the operation and maintenance of the South Pasadena Public Library, including technology upgrades, resources for students, and programs such as family story time and summer reading, shall an ordinance be adopted extending South Pasadena's Library Special Tax, which is due to expire on June 30, 2024, to remain in effect until otherwise terminated by a majority vote of the South Pasadena electorate?

Fiscal Impact

An invoice itemizing the costs to conduct the consolidated election with the County of Los Angeles has not yet been received by the City Clerk's Office, and is anticipated no later than March 2023. It is anticipated that costs will be similar to those incurred for the 2020 election, which was \$86,683.47. Sufficient funds are budgeted for Fiscal Year 2022-23 under Account No. 101-1020-2022-8170.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH PASADENA, CALIFORNIA, RECITING THE FACT OF THE CITY OF SOUTH PASADENA GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2022, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of South Pasadena, California, on Tuesday, November 8, 2022, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in General Law cities; and

WHEREAS, pursuant to Resolution Nos. 7767, 7768, 7782, and 7783, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, which are attached hereto and made a part herein as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH PASADENA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the names of the persons voted for at the election for Member of City Council are as follows:

District 4 – Michael A. Cacciotti

District 5 – Janet Braun

SECTION 2. That the names of the persons voted for at the election for one City Treasurer are as follows:

City Treasurer – Alan Ehrlich, Zhen Tao

SECTION 3. That the whole number of ballots cast and the number of ballots cast for the above-named office are listed in "Exhibit A," attached hereto and made a part herein.

SECTION 4. That the ballot measure submitted to the voters is as follows:

To maintain funding for the operation and maintenance of the South Pasadena Public Library, including technology upgrades, resources for students, and programs such as family story time and summer reading, shall an ordinance be adopted extending South Pasadena's Library Special Tax, which is due to expire on June 30, 2024, to remain in effect until otherwise terminated by a majority vote of the South Pasadena electorate?

SECTION 5. That the City Council does declare and determine that: Michael A. Cacciotti was elected as Member of the City Council in District 4 for a full term of four years and Janet Braun was elected as Member of the City Council in District 5 for a full term of four years;

SECTION 6. That the City Council does declare and determine that: Zhen Tao was elected as City Treasurer for a full term of four years

SECTION 7. That the whole number of ballots cast and the number of ballots cast for and against Measure LL are listed in "Exhibit B," attached hereto and made a part herein.

SECTION 8. That the City Council does declare and determine the passage of Measure LL by a majority of votes cast in the General Election.

SECTION 9. The Chief City Clerk shall enter on the records of the City of South Pasadena, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) The measure voted upon; (4) For what office each person was voted for; (5) The number of votes given at each precinct to each person, and for and against the measure; and (6) The total number of votes given to each person, and for and against the measure.

SECTION 10.
