Most importantly, advocate on behalf of those who cannot speak for their own selves and those who are afraid to speak on their own behalf.

That is principally why I have spoken to this body for the past three years, primarily as a mouthpiece for the sake of those just mentioned, as well as my citizen interests. I've also served as a mouthpiece as an employment industry consultant to deliver guidance when those on the dais have expressed concerns.

Here we are in December 2023. It's a time to reflect on the matters that were started shortly after my return to South Pasadena, especially the Sundown Town, Armenia, and Ukraine proclamations. It's a time to generally look at the progress we've made, especially in this year and consider the destination of path we're building.

We have some major challenges such as infrastructure and transportation, good communication, inclusion and acknowledgement of the protected classes, creating a wholesome and <u>thriving</u> community, developing venues that cater to constructive conversation that leads to positive results because of better mutual understanding.

I've watched as those who sit on the dais listen to the concerns presented. I've watched as notes were quickly written as the numerous speakers presented their cause. As we wind down 2023, the positive inroads from the care this body enacted in response to those concerns shows.

The State of the City address was delivered at the Senior Center. That choice of venue acknowledged the importance of our senior and disabled demographics. Contrary to the 1970s South Pasadena Rose Parade float where the police officer rolled up the sidewalks at 6 PM, we now actively produce numerous evening and weekend community activities. Those of all ages with impairments as well as able-bodied are equally included in outdoor activities ranging

from Arroyo Fest to walking tours to concerts and movies in the park that are somewhat accessible to those with impairments not only during the day but also in the evenings and weekends.

Hoorah!

Just as I expressed my desire last year to see the Invisible 3% become uncloaked, it would be good to see that demographic more widely dispersed in 2024.

Last month a long-time resident expressed one of the unspoken community standards by saying (by necessity, I paraphrase), "In South Pasadena, we like what we are and don't like change."

Likewise, it's time to posit this reflection and challenge. What can be done to help those who have a stranglehold on the standards of the past, ease that grip and embrace the forward look at, step by step, building a strong, vibrant and inclusive community in fact, not in mere appearance? Which of us can take responsibility for releasing the hold on the myths that haunt our society as we look at our population and see the humanity of and in each face?

With great enthusiasm, I look forward to what will be meted out for this city for 2024.
