Care First South Pasadena thanks you for the opportunity to comment.

We laud the city's efforts over the past year to address the housing affordability crisis, however the new year is quickly growing old and Care First South Pasadena is worried the city seems to be losing momentum in helping to solve the problem.

Specifically, Care First applauds the city's work last year to amend the just cause eviction ordinance to protect tenants, as well as its monumental effort to finally file what appears to be a compliant Housing Element with the California Department of Housing & Community Development. We further are glad to see the city has moved to amend its zoning standards to allow for greater density to clear the way for increasing the region's housing supply.

However, much more is needed. For instance, Care First South Pasadena calls on the city to expeditiously complete additional actions in the Housing Element aimed at housing affordability.

First, we remind the city that its Housing Element called for adopting a Rent Stabilization policy by December of 2023 and developing a Rental Property Registry no later than this month (February 2024). Neither of these actions have been publicly discussed, much less completed. In addition, it appears that several other actions outlined in the Housing Element are lagging, including:

- An informational campaign that ostensibly was to be conducted between June and December of 2023 aimed at removing racial covenants from the deeds for properties in the city;
- Outreach to developers, which was pledged by December of 2023, for development of affordable housing on city-owned properties; and
- Launching a reasonable accommodation process for tenants with disabilities, which was promised by December of 2023.

Given the ongoing housing supply and affordability crisis, Care First South Pasadena also urges the city to complete its Housing Element pledge to purchase and convert vacant Caltrans homes to affordable housing. The city told the community in 2022 that it would purchase the unoccupied homes by May of 2023, but nothing happened. Nine months later, the homes remain vacant, rotting in the rain.

The city also needs to get to work on a robust housing rehabilitation and code enforcement program, as outlined in the Housing Element. While this is not promised until October of this year, given the need to complete already overdue actions, we are concerned this program will lag as well, if not fall by the wayside.

Finally, to prevent the existing backlog of actions on housing from growing, Care First South Pasadena suggests the city staff provide regular updates during public City

Council meetings every 3 months so the Housing Element does not wind up collecting dust on the shelf. Regular updates will keep the Housing Element front and center and make sure it's actually carried out.

Dear Mayor Zneimer, Mayor Pro-Tem Donovan and Council:

On March 24, South Pasadena Tenants Union remitted a letter of support to California HCD encouraging the State to accept the fifth draft of the Housing Element. After reading the version of the Housing Element dated March 7, 2023, we believed that what was contained therein would achieve the required goals and affirm affordable housing at a level that was acceptable to our membership. Goal 6.0 is an item that contains four tenant protections.

While we have had our concerns about the many metamorphoses of the zoning since the release of the March 7, 2023 version of the 5th draft Housing Element, we remained supportive and trusted that the City of South Pasadena would go forward in good faith with the State, Californians for Homeownership, South Pasadena Tenants Union and those members of the public who wrote in support. However, after experiencing the transformation of many areas of the Housing Element and watching several revisions being approved by the Council since March 7, 2023, we are now concerned.

Anne Bagasao from SPTU met with City staff to inquire about several items within the Housing Element, described by the city as "milestones" in a report to HCD on December 18, 2023. In review of the report of "milestones", SPTU membership is dissatisfied with what the city claims are "milestones".

Unfortunately, December 2023 has come and gone, and we have yet to see rent stabilization and relocation assistance programs presented to the Council. It is our understanding that the city released an RFP for a consultant to provide Rent Stabilization Analysis and Program Design just this week. While we are relieved to learn you are finally taking this seriously and slowly moving towards accomplishment of Goal 6.0, we are disappointed that staff was not forthcoming in answering our inquiry about a plan and timeline for rent stabilization and relocation fees. We also wonder how long this process will take given that most of your consultants studies and deliverables go vastly over deadline and in the end cost tens of thousands of dollars more than anticipated.

For years, SPTU has worked with the city in good faith. Our members are engaged, involved and committed and yet the city continues to regard us with something we can only describe as disrespect.

For example: In October 2022, when the city held a community meeting regarding the CalTrans homes, CareFirst and SPTU were the last to be informed. We were given many explanations from Assistant City Manager Megerdichian as to why our groups were notified only days before the meeting. A public records request revealed that many other community members were noticed of

the event in communication at least seven days in advance of when the general public was noticed.

When SPTU asked City Manager Chaparyan why CareFirst and SPTU were not given the same consideration as the long list of individual residents who received direct notice from Assistant City Manager Mergerdichian, we were told that it was because those residents were more closely involved and impacted by the issue.

On that email distribution list was Mary Urquhart. Mary is not affected by the CalTrans home issue as she lives on Chelton Way. Why was she noticed in advance of the public and SPTU and CareFirst were not? Both CareFirst and SPTU had participated in this issue via public comment, attending council meetings, and having individual meetings with Council, Senator Portantino's office, Assemblymember Mike Fong's office, Assemblymember Holden's office and CalTrans. We were and remain closely involved and yet we were not noticed.

If any group is closely involved with tenants issues it is SPTU. We wrote your letter of support to HCD as we promised. We did not protest about the zoning shell game being played with the various versions of the Housing Element, although perhaps we should. We were patient and persistent with the Renoviction Ordinance process. We gave the city the grace and courtesy to meet the December 2023 goal for presentation of rent stabilization and relocation fees without much pressure. We met with your staff to inquire as to the status asking specifically when we could expect rent stabilization to be address and yet, the City of South Pasadena can not provide with the courtesy of informing us of renter related RFPs in an act of partnership and goodwill.

South Pasadena Tenants Unions demands that the City of South Pasadena prioritize rent stabilization and increase relocation fees. We cannot wait until August when the new state cap goes into effect. We cannot November or December. South Pasadena renters remain extremely vulnerable to unaffordable rents, because of the lack of local rent control and owner move in no fault just cause evictions. We are losing our homes now.
