Housing Rights Center

Housing Counseling

Housing Rights Center (HRC) housing counselors provide legal information on fair housing issues and a variety of landlord-tenant issues, including but not limited to questions about rent increases, security deposits, notices, lease terms, and requesting repairs.

Stay Housed L.A.

Legal Assistance

Stay Housed L.A. is a partnership between the County of Los Angeles, the City of Los Angeles, and local community and legal service providers that provides tenants facing eviction with legal information and support. Tenants who have received eviction notices should go directly to Stay Housed LA for free in-legal services (if income-eligible and depending on staffing capacity) or for referrals to private attorneys who charge for their services.

If you have received an eviction lawsuit (an Unlawful Detainer), you have only 5 business days to file an answer.

Neighborhood Legal Services of Los Angeles County (NLSLA) provides free legal services to low-income individuals across Los Angeles County, including tenants. NLSLA can help with housing issues related to tenant protections, disability accommodations, eviction defense, illegal rent increases, housing discrimination, unsafe living conditions, section 8 and public housing, and tenants experiencing domestic violence.

Legal Assistance

Legal Aid Foundation of Los Angeles (LAFLA) provides free legal services, including direct representation, counsel and advice, and referrals, to people across Greater Los Angeles. LAFLA follows federal poverty guidelines and assists only people with income less than 125% of the federal poverty guidelines. However, sometimes people with income over 125% of the federal poverty guidelines can qualify as well. Call 800-399-4529 to see if you qualify. LAFLA's self-help centers at courthouses (see locations below) can help anyone of any income level.
